I. ELIGIBILITY CRITERIA

1. The Bidder should have valid Service Tax registration number (If applicable) otherwise has to submit a Self-Declaration of "Non Applicability of Service Tax" (Format enclosed with this tender document) on their Company's Letter Head.
2. The Bidder should have valid Income Tax **PAN Card**. Documentary proofs / Xerox copies are to be enclosed.
3. The agency could be a Proprietorship/ Partnership Firm/LLP/One person Company/Private Limited Company/Public Limited Company/Trust/Society in this line of service / business - documentary proof / Xerox copy to be enclosed.
4. The bidders shall have minimum Three Years' experience (as on 31.03.2015) during the last 7 years in executing contract works / Non-core production support services in any industry using unskilled workers. Documentary evidence for execution of above work in any Central / State Govt. / PSU Company/Private Organisation shall be submitted along with the bid. Experience certificate from private organisation to be supported by TDS (Tax Deduction at source) certificate issued by the organisation or Form 26 AS or Bank statement as a proof of Payment.
5. The average annual turnover during the last 3 financial years ending 31.03.2014 should be minimum ₹ 15.4 Lakhs. Audited Financial Statements comprising Balance sheet, Profit & Loss accounts and notes to accounts if any, shall be submitted along with the bid.
6. On award of contract, the successful bidder shall comply with all the statutory requirements of PF rules & regulations for their workmen deputed for this work. An undertaking of acceptance (**refer point No.07 of Technical bid**) has to be given.
7. On award of contract, the successful bidder shall comply with all the statutory requirements of ESI/GI rules & regulations for their workmen deputed for this work. An undertaking of acceptance (**refer point No.08 of Technical bid**) has to be given.

2. For supervising the work, SSLC passed three workers shall be engaged during execution of the work.
3. The minimum age of the individual shall be 18 yrs.
4. The individual shall be physically and mentally fit to work in an industrial environment.
5. No lady / women workers shall be engaged.

- (a) L1 bidder - 50% of the quantity will be awarded.

3. If only one bidder accepts the counter offered L1 rate, then this bidder will be awarded with 30% (b) of the quantity. In this case, 50% (a) quantity was ordered to the L1 bidder and for the balance 20% (c) quantity, separate action will be initiated.

C. TIMING FOR WORK:

The contract labour have to work in BHEL related shift timings as below.

"C" Shift	:	from 10.00 PM to 06.00 AM (next day)
"G" Shift	:	from 07.30 AM to 04.30 PM
"N" Shift	:	from 04.00 PM to 01.00 AM (next day)

NOTES:

1. In case of need, the working time will be extended by TWO hours on the day of Duty.
2. For work on Sundays and Holidays (except National Holidays), regular shift will be operated with advance information.
3. The working time accounted against the individual will be certified by BHEL staff only based on the actual engagement time and the work output recorded.

D. DEPLOYMENT OF WORK FORCE:

1. The nature of work will vary from time to time depending on the shop-floor loading, leading to change in strength of workmen to be deployed - with likely condition of break in service requirement and change in operating Shifts - but with advance information from BHEL.
2. Two supervisors shall be deployed on every day – so that minimum one supervisor is made available in General and Night shifts - who shall be responsible to complete the assigned work within the time frame indicated.
3. Shift wise attendance register with 'IN' and 'OUT' timing shall be maintained by the supervisor and shall be countersigned by the BHEL Staff, at the end of each shift / duty.
4. The workmen deployed shall wear uniform (cotton mixed jet black trousers and steel gray plain full sleeve shirts), black industrial safety shoes, yellow colour industrial helmet, safety goggles, hand gloves and identification card within BHEL plant premises. The Uniform and PPEs shall be arranged by the contractor at the cost of the contractor. The practice and implementation of usage of safety PPEs is the whole responsibility of the contractor.
5. Workmen shall be deployed on a minimum number and as instructed by BHEL executives.

6. Approximate Requirement of Man-days: For the above scope the tentative requirement of man-days is as below.

- "A" Shift : 3 (Three)
- "B" Shift : 3 (Three)
- "C" Shift : 3 (Three)
- "G" Shift : 35+6 (Forty one)
- "N" Shift : 16 (Sixteen)
- 66 Unskilled labours are required per day for all A, B, C, G & N shifts, approximately.

Hence, the total Man-days required per year (302 x 66) = 19932 Man-days.

E. GENERAL CONDITIONS:

1. Power, fuel, machinery and material handling equipment, etc. will be under the scope of BHEL.
2. The contractor may avail BHEL canteen facilities if any for the contract workers attending the cited contract work and the subsidised cost for the same as applicable, shall be debited to the contractor's account.
3. The contractor shall mobilize workforce to BHEL premises at his own cost and risk.
4. The contractor shall follow and comply with PF and ESI / Group Insurance and other statutory regulations as stipulated in Factory's Act and associated State as well Central Government rules and regulations.
5. BHEL is in no way responsible for any loss of life or any injury caused to any of the contractor's workmen or equipment while executing the above contract work at BHEL premises.
6. The contractor's crew shall handle the machinery and other equipment entrusted to them by BHEL with utmost care and return them safely after execution of stipulated work. The cost of damage, repair due to improper handling of machinery and equipment will be recovered from the contractor.
7. BHEL reserves the right to alter any of the terms & conditions of the contract and any such changes will be intimated to the contractor from time to time.
8. BHEL reserves the right to cancel and terminate the contract at any time without assigning any reason.
9. The contractor should maintain a 'Work Diary' containing the details of work executed by him from time to time on daily basis and obtain the signature from official concerned nominated for this purpose for having executed the work correctly and satisfactorily.

11. The bill should be submitted monthly during the succeeding month of execution of work during each calendar month.
12. Necessary gate entry pass will be issued by BHEL Security department BHEL on User Department recommendation for your crew and Security rules shall be observed strictly by the contractor and their crew.
13. Clearance for bills payment will be processed only against certification for the equivalent tonnage by BHEL User Departments.
14. After obtaining the certification, the invoice shall be prepared by the contractor on Rate per MT basis. For this purpose for each man day of work attended against this contract is taken as equivalent to manufacturing of 800 Kg of boiler products at PPPU shop floor. (i.e., One man-day = 0.8 MT).

IV. COMMERCIAL TERMS & CONDITIONS:

01. RATE:

- a) Unit rates should be quoted in figures as well as in words with reference to the item shown in the attached schedule. These rates shall be for the specified work in site.
- b) Rate for the item of the tender schedule should be quoted in Rupees and paise only as per the Work / Rate schedule both in figures and words. In case any difference in rates quoted to figures and in words, the rate quoted in words will be taken as the tendered rate.
- c) If, in the price structure quoted for the required goods services works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- d) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
- e) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date upto which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- f) The rates quoted should be exclusive of service tax and inclusive of any other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.
- g) All entries in the tender documents should be made in one ink. Erasure and over-writing are not permitted. All cancellations and insertions should be duly signed by the Tenderer concerned.
- h) Before tendering, the tenderers are advised to inspect the site of work and its environments and be well acquainted with the actual working and other relevant conditions, position of materials and labour.

- i) The rates quoted in the tender shall remain valid initially for a period of at least “THREE MONTHS” from the date of opening of Price Bid/RA. After successful award of contract, the rates shall be firm throughout the contract period.
- j) Service Tax Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances.

OTHER CONDITIONS:

- Contractor shall watch and safeguard Employer's interests during the performance of the work.
- In case of non-fulfilment of quality standard the risk purchase clause would be operated and BHEL would engage alternate arrangement of subjects services at the cost of contractor.
- The labourers engaged under this contract should not be permitted to stay inside BHEL works after completing their day's work. It will be the responsibility of the contractor to take the labourers out of BHEL works as soon as their day's work is over.
- The contractor should ensure that the contract workers do not smoke in BHEL Premises and all safety measures should be ensured in Gas cooking systems.
- Contract workmen shall not indulge in horseplay of any kind inside the plant and they should not act in a manner that would distract the attention of other employees.
- In case BHEL be held liable for any loss, damage or compensation to the third parties arising by the contractor, such loss, damage or compensation shall be paid by the contractor to BHEL together with the costs incurred by BHEL on any legal proceeding pertaining thereto.
- The contractor is directly responsible for injuries / death of any person employed by him as well as to the third party occupants or other users arising due to accident or otherwise during the contractual period. At any point of time, BHEL will not be responsible for any loss / damage.
- If a Bidder deliberately gives wrong information in his tender or creates conditions favourable for the acceptance of his tender, the BHEL RESERVES THE RIGHT TO REJECT SUCH TENDER AT ANY STAGE.
- Words imparting singular number shall be deemed to include plural number and vice-versa where the context so requires.
- Should a tenderer find discrepancies or omissions in the drawings or any of the tender documents should be in doubts as to their meaning; he should at once address the authority inviting the tender for clarifications. Every endeavour is made to avoid any error which can materially affect the basis of the tender but the successful tenderer shall be taken upon himself to provide for the risk or any error which may be subsequently discovered and shall make no subsequent claim on account thereof.

- Canvassing in any form w.r.t. tenders is strictly prohibited and the tenders submitted by contractors who resort to canvassing are liable for rejection.
- In the event of tender being submitted by the firm, the tender must be signed separately and legibly by each partner or member of the firm or in their absence, by the person holding the power of attorney on behalf of the firm concerned. In the latter case, a copy of the power of attorney duly attested by a Gazetted Officer must accompany the tender.
- Every tender must be accompanied by Deposit receipt for the amount mentioned in this tender notice as Earnest Money Deposit in the form of Pay order or Demand Draft duly pledged in favour of BHEL, Thirumayam. EMD shall not carry any interest. One time EMD of ₹ 2 lakhs can also be paid.
- This Earnest Money Deposit will be refunded to the unsuccessful tenderers within 15 days on finalization of the award of work. In the case of successful tender, the earnest Money Deposit will be retained as part of the Security Deposits for satisfactory completion of the work. If the bidder withdraws his offer after submission of tender or after acceptance of tender or fails to start the work, the EMD shall be forfeited.
- BHEL reserves the right to

- BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders have to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
- In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit „online sealed bid“ in the Reverse Auction. Non submission of „online sealed bid“ by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

BHEL will remit 100% of service tax to Govt. in case L1 vendor is individual, or firm or HUF and for other form of organisation on proof of submission of challan reimbursement of service tax will be paid by BHEL.

02. PAYMENT TERMS:

The consolidated statements and Bills in triplicate shall be prepared by the Contractor after the completion of Non-core Production Support Services covered under scope of work and submitted to concerned **End User (OP&C)** & after due certification from **End User(OP&C)**, the bill will be forwarded to Accounts Section. The payment will be made through RTGS / EFT to the contractor immediately after the receipt of the error free bill. It is to be noted that it will take around ten days to process the bill at **End User (OP&C)** and Accounts section after submission.

03. CONTRACT PERIOD

- The contract execution period will be for a period of **1(one) year** from the date of commencement of work.
- If required, BHEL reserves the right to extend this subject contract for a further period under same terms and conditions subject to mutual acceptance of both parties.
- The contract may be terminated by BHEL due to violations or non-performance of the Contract conditions by giving one month's notice. In the event of contractor requiring termination, he has to provide 4 months' notice to BHEL.

of tools and plant and/or labour provided by the BHEL with an addition of such percentage to cover the super intendance and establishment charges as may be decided by the BHEL whose decision shall be final and conclusive.

18. TERMINATION OF CONTRACT ON DEATH OF CONTRACTOR. :-

Without prejudice to any of the rights or remedies under this contract, if the Contractor dies, or if the firm is dissolved or the company is liquidated BHEL shall have the option of terminating the contract without compensation to the Contractor.

19. SPECIAL POWER TO TERMINATION:- If at any time after the award of contract, BHEL shall for any reason whatsoever not require whole or any part of the work to be carried out the **HOD/M&S**, shall give notice in writing of the fact to the Contractor who shall have no claim to any payment of compensation or otherwise howsoever on account of any profit or advantage which he might have derived from the execution of the work in full but which he did not derive in consequence of the fore-closing of the work.

20. If the performance in whole or part of any obligation under this Contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by the **BHEL - PPPU** subject to prompt notification by the contractor.

23. ARBITRATION: - All disputes between the parties to the contract, arising out-of or relating to the contract, other than those for which the decision of the **HOS/User dept.**, or Accepting Officer or any other person is by the contract expressed to be final and conclusive shall after written notice by either party to the contract to the other party be referred to the sole Arbitration of Executive Director or other Officers of BHEL appointed as Arbitrator, by the Executive Director of BHEL in his sole discretion.

Unless the parties otherwise agree, such reference shall not take place until after the completion, alleged completion or abandonment of the work of the determination of the contract.

The venue of Arbitration shall be such a place or places as may be fixed by the Arbitrator in his sole discretion. The award of the Arbitrator shall be final, conclusive and binding on both parties to the contract.
