10. **Delivery Schedule :**

i) Delivery Schedule for this package shall be –

For Lot-I

Manufacturing of Lot-1 quantities shall be done after the approval of technical and quality documentation, and Supply of same shall be completed within two months of date of approval of documents.

For Lot-II

A lead-time of two months shall be given for completion of supply of each lot from the date of clearance of quantities.

ii) **Drawing document submission schedule:**

Initial submission of all the documents within 15 days from the date of PO and corresponding resubmissions in 7 days from the date of BHEL/customer comments.

iii) The total quantity variation shall be limited to (+) 30 % of the total contract value derived on the basis of the Order Quantities.
