The bidder along with its associate/collaborators/sub-contractors/sub-vendors/consultants/service providers shall strictly adhere to BHEL Fraud prevention policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.
16. **Indigenous bidders have to quote freight charges in percentage of their quoted Total Ex- works prices.**
17. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.  
In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit ‘online sealed bid’ in the Reverse Auction. Non-submission of ‘online sealed bid’ by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

Bidders are requested to refer ‘**Annexure-I to Terms & Conditions of Reverse Auction**’ enclosed along with tender enquiry.

18. Vendors shall have to enter into Integrity Pact with BHEL. The Integrity pact shall be returned by the bidder along with their Techno-commercial Bid, duly filled & signed by the authorized signatory and will form part of the order. Only those vendors/bidders who enter into Integrity Pact with BHEL, would be qualified to participate in the bidding Process. (Refer Annexure-IX, as per GCC Rev-06). In other words, entering into this integrity pact would be a preliminary qualification requirement.  
**To oversee implementation of Integrity Pact Sh. V. V. R SASTRY, EX-CMD/ BEL has been appointed Independent External Monitor (IEM) by BHEL.**
19. Bidders to quote their import content (CIF), if any in their price bid (Refer Annexure –CIF of Price Schedule). BHEL shall inform the availability of CIF value for the package including ceiling limit, if any, during commercial clarification/evaluation of offer.
20. BHEL reserves the right to finalize Prices by conducting Reverse Auction or by conventional way of price bid opening, which will be decided after techno-commercial evaluation. In view of above, bidders are requested to quote their most competitive prices as **no negative price impact** shall be applicable on account of non-conduction of RA.
