1. Pre-Qualifying Requirements:

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

2. Bidders have to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not approved by Customer (NLC), shall be subjected to approval of bidder by the customer.

a. Approval of bidder by Customer

Same shall be taken up by BHEL with the customer based on the credentials/reference list being submitted by the bidder. Bidders to note that following has to be the part of their credentials:-

- Documentary evidence to show that similar or higher capacity component/equipment/system has been supplied by the vendor or their associate/collaborator and the same has been operating satisfactorily for two years. The documentary evidence shall be in the form of Performance certificates furnished by the end user.
