TERMS AND CONDITIONS (In conjunction with Tender Enquiry Letter terms):

1. Bidders have to note that the Integrity Pact is applicable to this Tender. The integrity pact shall be returned by the bidders, along with their Techno-Commercial Bid, duly filled and signed by the authorized signatories, as per GCC Rev. 06 and will form the part of order. Only those bidders who have entered into an integrity pact with BHEL would be qualified to participate in the bidding. In other words, entering into this Integrity Pact would be a preliminary qualification.

2. **Pre-Qualifying Requirements:**

Bidders have to provide the required details as per TECHNICAL & FINANCIAL PRE-QUALIFICATION REQUIREMENT CRITERIA (enclosed as NIT Tender Documents) in its Techno-Commercial offer. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

3. Bidders have to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not approved by Customer (NLC), shall be subjected to approval of bidder by the customer.

- a. **Approval of bidder by Customer**

Same shall be taken up by BHEL with the customer based on the credentials/reference list being submitted by the bidder. Bidders to note that following has to be the part of their credentials:-

- Documentary evidence to show that similar or higher capacity component/equipment/system has been supplied by the vendor or their associate/collaborator and the same has been operating satisfactorily for two years. The documentary evidence shall be in the form of Performance certificates furnished by the end user.

4. Bidders have to note that TERMS AND CONDITIONS of the tender shall be as per General Conditions of Contracts (GCC, Rev. 06), Special Conditions of Contract of respective Projects and as per these Notice Inviting Tender (NIT) conditions.  - b. **Mandatory Spares:** Same as for Main Supply.
 - c. **E&C schedule:** Within three (03) Months from site clearance.
