**1. Pre-Qualifying Requirements:**

Bidders has to provide the required details as per "TECHNICAL AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (enclosed as NIT Tender Documents). Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

**2. Bidders has to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of those bidders, who are not registered with BHEL PEM / not approved by Customer (NLC), shall be subjected to following criterion:**

**a. Approval of bidder by the BHEL**

The bidders (who are not registered with BHEL-PEM) has to download the Supplier Registration Form (SRF) from [www.bhel.com](http://www.bhel.com) / [http:// www. bhelpem.com/ Vendor%20Corner.aspx](http://www.bhelpem.com/Vendor%20Corner.aspx) and submit the same duly filled in along with credentials-experience list, performance certificates and other statutory data to our Vendor Development section with intimation to us.

**b. Approval of bidder by Customer**

Same shall be taken up by BHEL with the customer based on the credentials/reference list being submitted by the bidder. Bidders to note that following has to be the part of their credentials:-

- Documentary evidence to show that similar or higher capacity component/equipment/system has been supplied by the vendor or their associate/collaborator. The documentary evidence shall be in the form of Material Receipt, Site Inspection Report, etc from the end user for having received the material by the end user.

**3.
