- a) The bidder should have completed erection, testing and commissioning of HT/LT Electrical works consisting of HT oil cooled transformer of rating of min 10 MVA, HT bus ducts of rating min 3.3 KV and other related works like HT / LT cable, switch gear, trays and tray supports, etc. in the last seven years.

**(or)**

The bidder should have completed erection, testing and commissioning of Total C&I systems of boiler or Turbine or station C&I and LT electrical works in a power plant of capacity min 210 MW in last seven years.

**(Or)**

The bidder should have completed erection, testing and commissioning of LT Electrical package comprising of bus ducts, transformers, switch gears, cables, tray work, earthing etc in a power plant of capacity min 110 MW in last seven years.

- b) The bidders should have a minimum average financial turn over of Rs.**77.00** Lakhs per year in the preceding three years ending 2007.

The bidder must have earned profit in any one of the last three financial years ending 31.03.2007 and should have positive net worth as on 31.03.2007

The bidder should submit audited balance sheet and profit and loss account of the company for the last three years ending 31.03.2007 in support of above requirement.
