I. ELIGIBILITY CRITERIA

1. The Bidder should have valid Service Tax registration number (If applicable) otherwise has to submit a Self-Declaration of "Non Applicability of Service Tax" (Format enclosed with this tender document) on their Company's Letter Head.
2. The Bidder should have valid Income Tax **PAN Card**. Documentary proofs / Xerox copies are to be enclosed.
3. The agency could be a Proprietorship/ Partnership Firm/LLP/One person Company/Private Limited Company/Public Limited Company/Trust/Society in this line of service / business - documentary proof / Xerox copy to be enclosed.

II. SCOPE OF CONTRACT:

1. Placing of the cited vehicle along with driver & cleaner at BHEL-Trichy (or) at BHEL-Thirumayam as instructed by executive/MM/PPPU, shall be within 12 hours on receipt of call, thro 'telephone or e-mail'.
2. Loading/helping for loading of materials at different (required) locations within BHEL.
3. Assisting to BHEL staff in documentation and during verification at BHEL Security point(s).
4. Safe transportation of the materials, to the destination point(s).
5. Unloading/helping in unloading of material at different location(s) within BHEL.
6. A trip from BHEL-Trichy to BHEL-Thirumayam or Vice Versa will be considered as a ONE TRIP.

III. WORK SPECIFIC TERMS & CONDITIONS:

- 1) Contractor contact details like Cell phone no., Land line no., and email id with address shall be provided to BHEL.
- 2) The vehicle shall be in good working condition. Transporter shall submit Vehicle details like Regn no., capacity, make, type and model year and Driver details like Name, age, experience, his contact no., during offer stage itself, and shall be maintained throughout the contract period. In case of change, due to any unforeseen reasons, permission shall be obtained from PPPU MM Executive in advance.
- 3) The contractor shall make alternate arrangement for safe and timely delivery of materials at the cost and risk of the contractor, in case of break down or any specific reason.
- 4) The rate shall be quoted per trip basis i.e. from BHEL-Trichy to BHEL-Thirumayam or vice versa. The rate quoted shall be inclusive of driver Bata, night halt, toll charges, entry charge, extra distance travel (due to road block, diversion of roads etc.), and all other incidentals. No extra charges will be paid other than the rate per trip. Hence all inclusive charges per trip shall be quoted by the bidders.
- 5) The contractor shall hand over all the materials safely to the consignee with all the relevant documents that are given at the loading points. In case of damage or loss of either materials or documents, the cost for rectifying the damage/ loss will be recovered from the contractors running bills/ security deposit.
- 6) Required hood, tarpaulin sheet etc., shall be used to protect the BHEL materials during rain,. etc., is the scope of the contractor.
- 7) Trips covered under this contract shall be exclusively for BHEL materials alone. Any other items/loads shall not be combined or clubbed along with BHEL trip loads.
- 8) Successful bidder should submit suitable transit insurance before commencement of work for a value not less than Rupees 2.00 lakhs, which shall cover each trip.
- 9) The driver shall have mobile phone for communication.
- 10) If any requirement for vehicle on Sundays/ holidays, the same shall be provided by the contractor. No additional payments in any manner will be given by BHEL for this Sunday/ holiday operations.
- 11) The contract may cover approximate 250 trips in one year. From BHEL-Trichy to BHEL-TMM will be considered as one trip and vice versa.
- 12) The payment will be made only for the actual number of trips. Acknowledgement shall be obtained for each trip and that should be submitted along with the bill.
- 13) The Contract will be for a period of one year from the date of commencement of work.

IV. COMMERCIAL TERMS & CONDITIONS:

01. RATE:

- a) Unit rates should be quoted in figures as well as in words with reference to the item shown in the attached schedule. These rates shall be for the specified work in site.
- b) Rate for the item of the tender schedule should be quoted in Rupees and paise only as per the Work / Rate schedule both in figures and words. In case any difference in rates quoted to figures and in words, the rate quoted in words will be taken as the tendered rate.
- c) If, in the price structure quoted for the required goods services works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- d) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
- e) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- f) The rates quoted should be exclusive of service tax and inclusive of any other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.
- g) All entries in the tender documents should be made in one ink. Erasure and over-writing are not permitted. All cancellations and insertions should be duly signed by the Tenderer concerned.
- h) Before tendering, the tenderers are advised to inspect the site of work and its environments and be well acquainted with the actual working and other relevant conditions, position of materials and labour.
- i) The rates quoted in the tender shall remain valid initially for a period of at least "THREE MONTHS" from the date of Technical bid opening`. After successful award of contract, the rates shall be firm throughout the contract period.
- j) Service Tax Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances.

OTHER CONDITIONS:

- Contractor shall watch and safeguard Employer's interests during the performance of the work.
- In case of non-fulfilment of quality standard the risk purchase clause would be operated and BHEL would engage alternate arrangement of subjects services at the cost of contractor.

- The labourers engaged under this contract should not be permitted to stay inside BHEL works after completing their day's work. It will be the responsibility of the contractor to take the labourers out of BHEL works as soon as their day's work is over.
- The contractor should ensure that the contract workers do not smoke in BHEL Premises and all safety measures should be ensured in Gas cooking systems.
- Contract workmen shall not indulge in horseplay of any kind inside the plant and they should not act in a manner that would distract the attention of other employees.
- In case BHEL be held liable for any loss, damage or compensation to the third parties arising by the contractor, such loss, damage or compensation shall be paid by the contractor to BHEL together with the costs incurred by BHEL on any legal proceeding pertaining thereto.
- The contractor is directly responsible for injuries / death of any person employed by him as well as to the third party occupants or other users arising due to accident or otherwise during the contractual period. At any point of time, BHEL will not be responsible for any loss / damage.
- If a Bidder deliberately gives wrong information in his tender or creates conditions favourable for the acceptance of his tender, the BHEL RESERVES THE RIGHT TO REJECT SUCH TENDER AT ANY STAGE.
- Words imparting singular number shall be deemed to include plural number and vice-versa where the context so requires.
- Should a tenderer find discrepancies or omissions in the drawings or any of the tender documents should be in doubts as to their meaning; he should at once address the authority inviting the tender for clarifications. Every endeavour is made to avoid any error which can materially affect the basis of the tender but the successful tenderer shall be taken upon himself to provide for the risk or any error which may be subsequently discovered and shall make no subsequent claim on account thereof.
- Conditional and late tenders, tenders containing prima-facie absurd rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in accordance with the tender conditions herein contained and the tenders not in original are liable to be rejected.
- Canvassing in any form w.r.t. tenders is strictly prohibited and the tenders submitted by contractors who resort to canvassing are liable for rejection.
- In the event of tender being submitted by the firm, the tender must be signed separately and legibly by each partner or member of the firm or in their absence, by the person holding the power of attorney on behalf of the firm concerned. In the latter case, a copy of the power of attorney duly attested by a Gazetted Officer must accompany the tender.

- This Earnest Money Deposit will be refunded to the unsuccessful tenderers within 15 days on finalization of the award of work. In the case of successful tender, the earnest Money Deposit will be retained as part of the Security Deposits for satisfactory completion of the work. If the bidder withdraws his offer after submission of tender or after acceptance of tender or fails to start the work, the EMD shall be forfeited.
- BHEL reserves the right to
 - Cancel the tender at any stage.
 - Finalize the contract through Reverse Auction / Price Bid Opening.
 - Negotiate or refloat the tender opened if L1 price is not the lowest acceptable price to BHEL inter-alia other reasons.
 - Decide on equally distributing and awarding the work to two or more vendors if same L1 rate is quoted by many vendors.
- BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders have to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
- In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit „online sealed bid“ in the Reverse Auction. Non submission of „online sealed bid“ by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
- All payments from BHEL in view of the execution of the contract are liable for IT (TDS), Service Tax, PF & Group Insurance and all other statutory provisions as applicable. Hence, bidders shall confirm that they have suitable mechanism for effective compliance to the same.
- Service Tax and all other taxes shall be shown extra in the bid. Bharat Heavy Electricals Limited, Thirumayam will not entertain any claim what so ever in this respect after opening the tenders. - (c) The contract may be terminated by BHEL due to violations or non-performance of the Contract conditions by giving one month's notice. In the event of contractor requiring termination, he has to provide 4 months' notice to BHEL.

04. EMD (EARNEST MONEY DEPOSIT): ₹20,000/- (Rupees Twenty thousand Only)

EMD shall be submitted by the bidder in the following forms:

- a) Demand Draft/Pay Order of Bank drawn in favour of **Bharat Heavy Electricals Limited** payable at **Thirumayam**, Pudukottai district (Tamil Nadu).
- b) Copy of the One Time EMD Cash receipt of amount **₹2 Lakhs** exclusively for BHEL, Thirumayam alone will be reckoned to allow participation in bids by bidders.

05. SECURITY DEPOSIT:

BHEL reserves the right to appropriate any part or the whole of the amount of the security deposit without prejudice to other claims against this Contractor for losses suffered by BHEL due to failures on the part of the Contractor or due to termination of contract or Contractor becoming disqualified because of liquidation / insolvency or change of composition. The decision of BHEL in respect of such losses, damages, charges, expenses or costs, shall be final and binding on the Contractor and the decision shall not be questionable.

- In order to ensure the genuineness of BG's, the BG's are to be sent directly by the concerned bank through registered post to Senior Manager / Contracts, Power Plant Piping Unit (PPPU), BHEL Thirumayam - 622 507.
- Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The FDR should be in the name of the contractor, A/C BHEL, duly discharged on the back and with minimum validity of covering the contract period.
- Security deposit can also be recovered at the rate of 10% from the running bills. However in such cases at least 50% of the Security Deposit should be remitted (any of the above form) by the vendor before start of work and the balance 50% may be recovered from the running bills.

The security deposit shall not carry any interest.

The Earnest Money paid at the time of tender will be converted as part of the Security Deposit and the balance amount will be collected from the contractor as mentioned above.

Against this enquiry for the subject item/ system with detailed scope of supply as per enquiry specifications, BHEL may resort to “REVERSE AUCTION PROCEDURE” i.e., ON LINE BIDDING (THROUGH A SERVICE PROVIDER). The philosophy followed for reverse auction shall be English Reverse (No ties).

1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
2. Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit „online sealed bid” in the Reverse Auction. Non-submission of “online sealed bid” by the bidder for any of the eligible items for which techno-commercially qualified will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet.

12. If the Bidder or any of his representatives are found to be involved in Price manipulation/ cartel formation of any kind, directly or indirectly by communicating with other bidders, action *as per extant BHEL guidelines*, shall be initiated by BHEL and the results of the RA scrapped/ aborted.

- 05. ASSIGNMENT OF TRANSFER OF CONTRACT:-** The Contractor shall not without the prior written approval of the BHEL, assign or transfer the contract or any part thereof, or any share, or interest thereon to any other persons. - 09. (b) being a Company, shall pass a resolution or the Court shall make an order for the liquidation of its affairs, or a receiver or Manager on-behalf of the debenture holders shall be appointed or circumstances shall arise which entitle the Court or debenture holders to appoint a receiver or Manager,

OR

(c) Assigns, Transfers, Sub-lets or attempts to assign, transfer or sub-let any portion of the work without the prior written approval of the BHEL.

- (d) Whenever BHEL exercise the authority to cancel the contract under this conditions, BHEL may have the work done by any means at the Contractor's risks and expenses provided always that in the event of the cost of the work so done (as certified by **HOD/User dept.** which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL and if the cost exceeds the money due to Contractor under the contract, the Contractor shall either pay the excess amount ordered by **HOD/User dept.** or the same shall be recovered from the Contractor by other means.
- (e) In case the BHEL carries-out the work under the provisions of this condition the cost to be taken into account in determining the excess cost to be charged to the Contractor under this condition shall consist of the cost of the materials, hire charges of tools and plants and/or labour provided by the BHEL with an addition of such percentage to cover superintendence and establishment charges as may be decided by the **HOD/Services**, whose decision shall be final and conclusive.

17. CANCELLATION OF CONTRACT IN PART OF FULL FOR CONTRACATOR'S DEFAULT:

If the Contractor:

- (a) makes default in carrying out the work as directed and continues in that state after a reasonable notice from **HOS/User dept.** or his authorized representative ;
- (b) fails to comply with any of the Terms and Conditions of the contract or after reasonable notice in writing with orders properly issued there under ;
- (c) BHEL, may without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL CANCEL the contract as whole or in part thereof or only such work order or items of work in default from the contract.

Whenever BHEL exercise the authority to cancel the contract as whole or part under this condition BHEL may complete the work at the contractor's risk and cost (as certified by **HOS/User dept.** , which is final and conclusive) being less than the contract cost, the advantage shall accrue to the BHEL. 20. RECOVERY FROM CONTRACTOR:- Whenever under the contract, any sum of money, shall be recoverable from or payable by the Contractors, the same may be deducted from or any sum then due or which at any time thereafter may become due to Contractor under the contract or under any other contract with BHEL or from his Security Deposit or he shall pay the claim on demand.

21. POST TECHNICAL AUDIT OF WORK AND BILLS:- BHEL reserves the right to carry out the post-payment Audit and technical examination of the work and final bill including all supporting vouchers, abstracts etc., and enforce recovery of any sum becoming due as a result thereof in the manner provided in the presiding sub-paragraphs. However no such recovery shall be enforced after three years of passing the final bill.

22. FORCE MEJEURE CLAUSE:- If, at any time during the continuance of this Contract the performance in whole or in part by either party of any obligations under this Contract shall be prevented or delayed by reason of any War, Hostile acts of the public enemy Civil Commotion, Epidemics, or Acts of God (Floods, Storm/Cyclone, Hurricane, Earth Quake etc.) then provided notice of happening of any such event is given by either party to other within 7 days from the date of occurrence therefore neither party shall by reason of such event be entitled to terminate this Contract nor shall either party have any claim for damages against the other in respect of such non-performance and delay in performance under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If the performance in whole or part of any obligation under this Contract is prevented or delayed by reason of any such event, claims for extension of time shall be granted for periods considered reasonable by the **BHEL - PPPU** subject to prompt notification by the contractor.
