### I. PRE - QUALIFICATION CRITERIA:

1. Earnest Money Deposit (EMD) – ₹ 20,000/- (Rupees Twenty Thousand Only).
2. The Bidder should have valid Income Tax PAN Card. Xerox copy of PAN card is to be enclosed.
3. The Agency could be a Proprietorship/ Partnership Firm/LLP/One person Company/Private Limited Company/Public Limited Company/Trust/Society in this line of service / business - documentary proof / Xerox copy to be enclosed.
4. The Bidder could be a manufacturer or distributor or dealer in this line of service / business. Documentary proof / Xerox copy is to be enclosed
5. If a bidder is distributor or dealer, then the certificate of distributorship / dealership from the original manufacturer shall be submitted along with the bid
6. The bidder shall have Valid License/Certificate from BIS (Bureau of Indian Standards) as per IS 14543:2004 and copy of the same shall be submitted along with the bid

### **NOTE:**

- Only those bidders, who are meeting all the above qualifying criteria, will be considered for further evaluation and others will be summarily rejected.
- The Pre-Qualification Criteria details as per Annexure - A to be filled & submitted with supporting documents for BHEL reference and verification. Documents submitted with the offer shall be signed & stamped in each page by authorized representative of the bidder, without which bids will not be considered for further evaluation

### II. SCOPE OF WORK

1. The estimated requirement of packaged drinking water -20 litres, 1 Litre and 300 Ml capacities is indicative in nature, which may vary based on the actual consumption. The actual consumption may be more or less, by upto 15% to 20%, than the indicated Work Order quantity.
2. Packaged Drinking Water shall be UV treated, RO processed and Ozonised and shall conform to the Bureau of Indian Standards (IS 14543:2004). Manufacturing date should be within two days of the supply date and the manufacturing date should be printed on the top/cap of the cans. BHEL reserves the right to reject the supply, if it is found to be unacceptable. The decision of BHEL in this matter shall be final.
3. The packaged drinking water bottles - 20 litres (water can), 1 Litre and 300 Ml capacities shall be provided in properly sealed condition. Water cans with broken/tampered seal will not be allowed and will be summarily rejected.
4. The refill bottles shall be delivered to our Factory, PPPU, BHEL, and Thirumayam at around 30 designated Water points located within a radius of about 750 meters.
5. The supplier shall provide the Bubble-top Water Dispenser (bottom part) fitted with suitable tap at free of cost. These dispensers will be returned back to the supplier at the end of contract. The total requirement of Bubble-top Water Dispensers will be about 100 Nos.
6. Both the Bubble-top Dispenser and the refill bottles of 20 Litres(water can) capacities, 1 litre bottles and 300 Ml bottles shall be made up of food grade plastic.
7. The supplier shall deliver the refill bottles (20 Litres) and collect the empty refill bottles on daily basis and on special request from BHEL. The delivery of refill bottles (20 Litres) should be done in the morning ( between 09.00 AM to 11:30 AM) Other bottles 1 Litre and 300 Ml shall also be supplied as and when required by BHEL.
8. The supplier shall quote the rates per refill bottle of 20 litres capacity, 1 Litre bottle and 300 Ml bottles. The rates shall be all inclusive of taxes, packing, delivery and supply at the designated water points in BHEL Thirumayam factory. There shall be no extra claim over and above the quoted unit rate.
9. BHEL reserves the right to counter offer the L1 rate with the other bidders to have more number of vendors.

10. The supplier shall submit the consolidated bill in the first week of every succeeding month. The bills will be processed and payment will be released immediately.
11. BHEL at its option will be entitled to purchase elsewhere at the risk and cost of the supplier either the whole of the goods or any part which the supplier has failed to deliver or dispatch within the time stipulated or if the same were not available i.e. in case any shortage of drinking water cans arises on any day for the reason(s) which are attributable to lapse on part of the vendor (in this regard the onus is on the vendor towards studying the consumption trend and confirming any additional requirement for the next ensuing day with BHEL Administration on a daily basis)
12. Such purchases will be made from the best and the nearest available substitute. The vendor shall be liable for any loss which the Purchaser may sustain by reason of such risk purchases i.e. the cost in excess of the rates fixed in the work order/Purchase order will be recovered from the Vendor.
13. In addition to the above recovery in case of non supply/short supply, a penalty will also be imposed on the vendor. The penalty amount will be the Work Order/Service Purchase Order unit rate (UR) for 20 Litre Cans times 58 times the number of days of Non supply/Short Supply (NS), i.e., the penalty amount will be  $UR \times 58 \times NS$  (INR).
14. Packaged Drinking Water manufacturer shall submit BIS Certificate/License copy along with the quotation. The certificate/License should be valid during the contract period.
15. Packaged Drinking Water manufacturer can submit quotation directly from their end. Distributor / Dealer shall obtain a Certificate of Distributorship / Dealership from the original manufacturer. However, the Distributor /dealer will have to produce the BIS License/certificate for the manufacturer which should be valid throughout the contract period as specified in Point no. 15.
16. If BHEL makes any alternate arrangement for drinking water requirement the contract will be short closed with one month notice to the contractor.

**III. COMMERCIAL TERMS & CONDITIONS:**

Sealed Tenders for the work enclosed are hereby invited from contractors meeting the qualifying criteria as stated. Tenderers should fill in all the required particulars in the blank spaces provided for this purpose in the tender documents and sign each and every page of the tender document including corrigendum & the drawing attached if any, while submitting their bid.

**1. RATE:**

- a) Unit rates should be quoted in figures as well as in words with reference to the item shown in the attached schedule. These rates shall be for the specified work in site.
- b) Rate for the item of the tender schedule should be quoted in Rupees and paise only as per the Work / Rate schedule both in figures and words. In case any difference in rates quoted to figures and in words, the rate quoted in words will be taken as the tendered rate.
- c) Rates should be quoted as per the **Price bid format**. Rates quoted in any other form will not be accepted and will be rejected.
- d) Contractor has to ensure that all statutory payment as per Minimum Wages Act / Payment of Wages Act etc. and BHEL additional monthly payment (as indicated in Welfare Conditions) to be taken care of while quoting. No claim in respect of payment to workmen will be entertained at a later stage. It will be responsibility of contractor to comply with statutory payments to workmen in this regard.
- e) If, in the price structure quoted for the required goods services works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- f) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and

- g) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (e) and (f) above.
- h) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- i) **The rates quoted should be inclusive of Service Tax & Swachh Bharat Cess and all other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.**
- j) All entries in the tender documents should be made in one ink. Erasure and over-writing are not permitted. All cancellations and insertions should be duly signed by the Tenderer concerned.
- k) Before tendering, the tenderers are advised to inspect the site of work and its environments and be well acquainted with the actual working and other relevant conditions, position of materials and labour.
- l) The rates quoted in the tender shall remain valid initially for a period of at least "THREE MONTHS" from the date of opening of Technical bid. After successful award of contract, these rates shall be firm throughout the contract period.
- m) Service Tax Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances.
- n) Should a tenderer find discrepancies or omissions in the drawings or any of the tender documents should be in doubts as to their meaning; he should at once address the authority inviting the tender for clarifications. Every endeavor is made to avoid any error which can materially affect the basis of the tender but the successful tenderer shall be taken upon himself to provide for the risk or any error which may be subsequently discovered and shall make no subsequent claim on account thereof.
- o) Conditional and late tenders, tenders containing prima-facie absurd rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in accordance with the tender conditions herein contained and the tenders not in original are liable to be rejected.
- p) Canvassing in any form w.r.t. tenders is strictly prohibited and the tenders submitted by contractors who resort to canvassing are liable for rejection.
- q) In the event of tender being submitted by the firm, the tender must be signed separately and legibly by each partner or member of the firm or in their absence, by the person holding the power of attorney on behalf of the firm concerned. In the latter case, a copy of the power of attorney duly attested by a Gazetted Officer must accompany the tender.
- r) Every tender must be accompanied by Earnest Money Deposit in the form of Pay order or Demand Draft in favour of BHEL, Thirumayam. EMD shall not carry any interest.
- s) This Earnest Money Deposit will be refunded to the unsuccessful tenderers within 15 days on finalization of the award of work. In the case of successful tender, the earnest Money Deposit will be retained as part of the Security Deposits for satisfactory completion of the work. If the bidder withdraws his offer after submission of tender or after acceptance of tender or fails to start the work, the EMD shall be forfeited.
- t) All payments from BHEL in view of the execution of the contract are liable for IT (TDS), Service Tax, PF & Group Insurance and all other statutory provisions as applicable. Hence, bidders shall confirm that they have suitable mechanism for effective compliance to the same.

**Terms & Conditions of Reverse Auction**

Against this enquiry for the subject item/ system with detailed scope of supply as per enquiry specifications, BHEL may resort to “REVERSE AUCTION PROCEDURE” i.e., ON LINE BIDDING (THROUGH A SERVICE PROVIDER). The philosophy followed for reverse auction shall be English Reverse (No ties).

1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
2. Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit “online sealed bid” in the Reverse Auction. Non-submission of “online sealed bid” by the bidder for any of the eligible items for which techno-commercially qualified will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet.
4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
5. Business rules like event date, time, bid decrement, extension etc. also will be communicated through service provider for compliance.
6. Bidders have to fax the Compliance form before start of Reverse auction. Without this, the bidder will not be eligible to participate in the event.
7. In line with the NIT terms, BHEL will provide the calculation sheet (e.g., EXCEL sheet) which will help to arrive at “Total Cost to BHEL” like Packing & forwarding charges, Taxes and Duties, Freight charges, Insurance, Service Tax for Services and loading factors (for non-compliance to BHEL standard Commercial terms & conditions) for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.
8. Reverse auction will be conducted on scheduled date & time.
9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal. The lowest bidder has to fax/e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required, (Annexure VII) as provided on case-to-case basis to Service provider within two working days of Auction without fail.
10. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the Price bids and price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL’s standard practice.
11. Bidders shall be required to read the “Terms and Conditions” section of the auctions site of Service provider, using the Login IDs and passwords given to them by the service provider before reverse auction event. Bidders should acquaint themselves of the “Business Rules of Reverse Auction”, which will be communicated before the Reverse Auction.
12. If the Bidder or any of his representatives are found to be involved in Price manipulation/ cartel formation of any kind, directly or indirectly by communicating with other bidders, action as per extant BHEL guidelines, shall be initiated by BHEL and the results of the RA scrapped/ aborted.

**3. CONTRACT PERIOD:**

- a) The contract execution period will be for a period of **1 Year** from the date of commencement of work.
- b) If required, BHEL reserves the right to extend this subject contract for a further period under same terms and conditions subject to mutual acceptance of both parties.
- c) The contract may be terminated by BHEL due to violations or non-performance of the Contract conditions by giving one month's notice. In the event of contractor requiring termination, he has to provide 4 months' notice to BHEL

**4. RISK PURCHASE:**

In the event of any successful Tenderer, after award of LOI / Contract fail to fulfil any of the Tender Terms & Conditions / Contract obligations, explicitly expressed or implied, as per contract/Contract agreement, BHEL will exercise their right to arrange and execute the same through alternate vendor/departmentally at the RISK and COST of the service provider and excess expenditure if any incurred will be deducted from the subjected Service provider's running bill / Security Deposit.

For this purpose, the modus operandi will be as follows:-

- a) BHEL will address by mail to all technically qualified vendors, and call for a price bid alone, giving only three days' time from the date of mail. The L1 rate obtained by this way, if acceptable to BHEL, Risk purchase order will be issued to L1 vendor.
- b) The additional expenditure / difference in Cost, if any, including consequential cost shall be recovered from the defaulted vendor.
- c) The decision of BHEL with regard to arriving at the total cost of recovery from the vendor shall be final.
- d) It shall be noted that **both Penalty clause and Risk Clause** will be imposed on contractor if the contractor fails to provide the service.

**V. GENERAL TERMS & CONDITIONS:**

**01. DEFINITION:** In these General Conditions of Contract, the following terms shall have the meaning hereby assigned to them, except where the context otherwise requires:

- a) The "**Contract**" means, the documents forming the tender and acceptance thereof, together with all the documents referred to therein including general and special conditions to contract. All these documents as applicable taken together shall be deemed to form one contract and shall be complementary to one another.
- b) The "**work**" means, the work described in the tender documents in individual work-orders as may be issued from time to time to the contractor by the Officer In-charge within the power conferred upon him including all notified or additional items of works and obligations to be carried out as required for the performance of contract.
- c) The "**contractor**" means, the individual Firm or Company whether incorporated or not, undertaking the work and shall include the legal personal representatives of such individuals or the persons composing the firm or Company or the successors of the firm or company and the permitted assigns of such individual or firm or Company.
- d) "**The Officer-In charge**" means, the Officer deputed by the Head of Dept./Executing Dept., to supervise the work or part of the work.
- e) "**Approved**" and "**Directed**" means, the approval or direction of Head of Unit/PPPU-THIRUMAYAM, or person deputed by him for the particular purposes.
