I. PRE - QUALIFICATION CRITERIA

1. Earnest Money Deposit (EMD) – ₹10,000 /- (Rupees Ten Thousand Only)
2. The Bidder should have valid Income Tax **PAN Card**. Documentary proofs / Xerox copies are to be enclosed.
3. The Bidder should have valid Service Tax registration number (If applicable) otherwise has to submit a Self-Declaration of "Non Applicability of Service Tax" (Format enclosed with this tender document) on their Company's Letter Head.

7. The rate quoted shall be inclusive of driver Bata, night halt, toll charges and all other incidentals. No extra charges will be paid other than "Per day Fix rate" + "Per KM rate". Kilometers Charges will be counted from Source to Destination only. Hence, bidders has to quote the charges of fuel per KM in Price Bid accordingly.
8. For evaluation purpose distance of 80Kms between BHEL Trichy and BHEL-PPPU will be taken.
9. The contractor shall hand over all the materials safely to the consignee with all the relevant documents that are given at the loading points. In case of damage or loss of either materials or documents, the cost for rectifying the damage/ loss will be recovered from the contractors running bills/ security deposit.
10. Trips covered under this contract shall be exclusively for BHEL materials alone. Any other items/loads shall not be combined or clubbed along with BHEL loads.
11. Required hood, tarpaulin sheet, etc., shall be used to protect the BHEL materials during rain, etc., is the scope of the contractor.
12. Successful bidder should submit suitable transit insurance before commencement of work for a value not less than Rupees 2.00 lakhs.
13. The driver shall have mobile phone for communication.
14. If any requirement for vehicle on Sundays/ holidays, the same shall be provided by the contractor. No additional payments in any manner will be given by BHEL for this Sunday/ holiday operations.
15. The contract may cover approx. 500 days in one and a half year.
16. The payment will be made only for the Fixed cost + actual number of running kilometers. Acknowledgement on log book shall be obtained for each day and that should be submitted along with the bill.
17. The Contract will be for a period of 18 months from the date of commencement of work.
18. The vehicle should have proper measuring instrument (odometer) for correct measurement of distance.

IV. COMMERCIAL TERMS & CONDITIONS:

Sealed Tenders for the work enclosed are hereby invited from contractors meeting the qualifying criteria as stated. Tenderers should fill in all the required particulars in the blank spaces provided for this purpose in the tender documents and sign each and every page of the tender document including corrigendum & the drawing attached if any, while submitting their bid.

01. RATE:

- a) Unit rates should be quoted in figures as well as in words with reference to the item shown in the attached schedule. These rates shall be for the specified work in site.
- b) Rate for the item of the tender schedule should be quoted in Rupees and paise only as per the Work / Rate schedule both in figures and words. In case any difference in rates quoted to figures and in words, the rate quoted in words will be taken as the tendered rate.
- c) Rates should be quoted as per the **Price bid format**. Rates quoted in any other form will not be accepted and will be rejected.
- d) Contractor has to ensure that all statutory payment as per Minimum Wages Act / Payment of Wages Act etc. and BHEL additional monthly payment (as indicated in Welfare Conditions) to be taken care of while quoting. No claim in respect of payment to workmen will be entertained at a later stage. It will be responsibility of contractor to comply with statutory payments to workmen in this regard.
- e) If, in the price structure quoted for the required goods services works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- f) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and

- g) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (e) and (f) above.
- h) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- i) **The rates quoted should be exclusive of Service Tax, Swachh Bharat Cess & Krishi Kalyan Cess and inclusive of any other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.**
- j) All entries in the tender documents should be made in one ink. Erasure and over-writing are not permitted. All cancellations and insertions should be duly signed by the Tenderer concerned.
- k) Before tendering, the tenderers are advised to inspect the site of work and its environments and be well acquainted with the actual working and other relevant conditions, position of materials and labour.
- l) The rates quoted in the tender shall remain valid initially for a period of at least "THREE MONTHS" from the date of opening of Technical bid. After successful award of contract, these rates shall be firm throughout the contract period.
- m) Service Tax Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances.
- n) Should a tenderer find discrepancies or omissions in the drawings or any of the tender documents should be in doubts as to their meaning; he should at once address the authority inviting the tender for clarifications. Every endeavor is made to avoid any error which can materially affect the basis of the tender but the successful tenderer shall be taken upon himself to provide for the risk or any error which may be subsequently discovered and shall make no subsequent claim on account thereof.
- o) Conditional and late tenders, tenders containing prima-facie absurd rates and amounts, tenders which are incomplete or otherwise considered defective and tenders not in accordance with the tender conditions herein contained and the tenders not in original are liable to be rejected.
- p) Canvassing in any form w.r.t. tenders is strictly prohibited and the tenders submitted by contractors who resort to canvassing are liable for rejection.
- q) In the event of tender being submitted by the firm, the tender must be signed separately and legibly by each partner or member of the firm or in their absence, by the person holding the power of attorney on behalf of the firm concerned. In the latter case, a copy of the power of attorney duly attested by a Gazetted Officer must accompany the tender.
- r) Every tender must be accompanied by Earnest Money Deposit in the form of Pay order or Demand Draft in favour of BHEL, Thirumayam. EMD shall not carry any interest.
- s) This Earnest Money Deposit will be refunded to the unsuccessful tenderers within 15 days on finalization of the award of work. In the case of successful tender, the earnest Money Deposit will be retained as part of the Security Deposits for satisfactory completion of the work. If the bidder withdraws his offer after submission of tender or after acceptance of tender or fails to start the work, the EMD shall be forfeited.
- t) All payments from BHEL in view of the execution of the contract are liable for IT (TDS), Service Tax, PF & Group Insurance and all other statutory provisions as applicable. Hence, bidders shall confirm that they have suitable mechanism for effective compliance to the same.
- u) Service Tax Registration form / Self-declaration for non-applicability of Service Tax have to be provided as applicable.

Terms & Conditions of Reverse Auction

Against this enquiry for the subject item/ system with detailed scope of supply as per enquiry specifications, BHEL may resort to “REVERSE AUCTION PROCEDURE” i.e., ON LINE BIDDING (THROUGH A SERVICE PROVIDER). The philosophy followed for reverse auction shall be English Reverse (No ties).

1. For the proposed reverse auction, technically and commercially acceptable bidders only shall be eligible to participate.
2. Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit “online sealed bid” in the Reverse Auction. Non-submission of “online sealed bid” by the bidder for any of the eligible items for which techno-commercially qualified will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet.
4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
5. Business rules like event date, time, bid decrement, extension etc. also will be communicated through service provider for compliance.
6. Bidders have to fax the Compliance form before start of Reverse auction. Without this, the bidder will not be eligible to participate in the event.
7. In line with the NIT terms, BHEL will provide the calculation sheet (e.g., EXCEL sheet) which will help to arrive at “Total Cost to BHEL” like Packing & forwarding charges, Taxes and Duties, Freight charges, Insurance, Service Tax for Services and loading factors (for non-compliance to BHEL standard Commercial terms & conditions) for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.
8. Reverse auction will be conducted on scheduled date & time.
9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal. The lowest bidder has to fax/e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required, (Annexure VII) as provided on case-to-case basis to Service provider within two working days of Auction without fail.
10. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the Price bids and price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL’s standard practice.

02. PAYMENT TERMS:

- a) The consolidated statements and Bills in triplicate shall be prepared by the Contractor for the services rendered in the previous month and submitted to concerned **End User (MM/Stores) dept.** & after due certification from **End User(MM/Stores) dept.**, the bill will be forwarded to Accounts Section. The payment will be made through RTGS / EFT to the contractor immediately after the receipt of the error free bill. It is to be noted that it will take around 2 weeks to process the bill at **End User (MM/Stores) dept.** and Accounts section after submission.
- b) Invoice shall indicate W.O and W.O SI. No in all invoices for processing payment.

Note: Three copies of INVOICE with original signature to be submitted every month on completion of work.

03. PENALTY:

- a) In case the contractor fails to deploy the vehicle within 12 hours on receipt of call, thro telephone / e-mail, BHEL reserves the right to get the same done at the contractor's risk and cost by engaging another agency/departmentally with additional penalty of ₹ 500/- per day.
- b) In case of break-down of vehicle while on operation, the vehicle should be replaced by an alternative vehicle within 60 minutes from the time of breakdown. If it is not so, an amount of ₹150/- per hour (fraction of breakdown hours will be rounded off to full hour) will be deducted from the particular bill for the break down hours for maximum of 4 hours only, if break down time exceeds 4 hr., the subject Day Rent for the vehicle will not be given (as penalty) and payment will be given only for KM run.
- c) In case of non-replacement of vehicle in time as said above against breakdown Taxis, BHEL reserves the right to get the same done at the contractor's risk and cost by engaging the same departmentally. The excess amount if any towards that may be deducted from the default contractor's running bill / security deposit.
- d) In case of delay in placement of vehicle as instructed by BHEL executive an amount of ₹200/- per hour (fraction of breakdown hours will be rounded off to full hour) will be deducted from the particular bill for the delayed hours.

04. CONTRACT PERIOD:

- a) The contract execution period will be for a period of **18 Months** from the date of commencement of work.
- b) If required, BHEL reserves the right to extend this subject contract for a further period under same terms and conditions subject to mutual acceptance of both parties.

06. RISK PURCHASE:

- o Makes default in carrying out the work as directed and continues in that state after a reasonable notice from HOD/Executing Dept., or his authorised representative;
- o Fails to comply with any of the Terms and Conditions of the contract or after reasonable notice in writing with orders properly issued there under;
- o BHEL, may without prejudice to any other right or remedy which shall have accrued or shall accrue thereafter to BHEL CANCEL the contract as whole or in part thereof or only such work order or items of work in default from the contract.
