12. Pre-Qualifying Requirement:-

Bids of only those bidders shall be evaluated who meet the General, Technical and Financial pre-qualifying requirements, if applicable. Credentials of the bidders meeting the pre-qualifying requirements shall be taken up with customer for approval.

Only those bidders, whose offer is technically and commercially recommended, shall be allowed to participate in RA/ Price-Bid opening.

13. Indigenous Bidders to indicate their Import content (CIF) in their price bid and Nil Custom duty shall be considered by them. However the same will be reviewed during evolution of offers and any ceiling on CIF shall be intimated to Bidders during offer evaluation stage before Reverse Auction (RA) / opening price bid, if required.

14. Bidder to note that this is a conditional enquiry for those who are not registered with BHEL PEM and/or are not approved by Customer for the subject project/ package, and the price bid (Part-II) opening/RA shall be subject to following criterion :

a) Approval of bidder by BHEL

The bidders which are not registered with BHEL-PEM, refer Supplier Registration Form (SRF) attached with enquiry and submit the same duly filled (with signed & stamped) in along with credentials, experience list, performance certificates and other statutory data with their bids for vendor registration.

b) Approval of bidder by Customer

Approval shall be taken up by BHEL with customer based on the credentials/reference list. Hence Bidders are requested to submit the following (as part of their credentials) on or before technical bid Part-I opening:-

- i. Reference list indicating PO details, customer name, PO date, execution date etc.
- ii. Performance certificate issued by the clients.
- iii. Filled NTPC format for Main &Sub – Supplier Questionnaire attached with enquiry and all documents referred to in the questionnaire.

15. Indigenous bidders have to quote freight charges in percentage of their quoted Total ex-works price.

16. BHEL reserves the right to finalize Prices by conducting Reverse Auction or by conventional way of price bid opening (Refer Clause No. 13.0 of Instruction to Bidder, Volume-I, GCC Rev. 06), which will be decided after techno-commercial evaluation. In view of above, Bidders are requested to quote their most competitive prices as **no negative price impact** on account of non-conduction of RA shall be asked for.

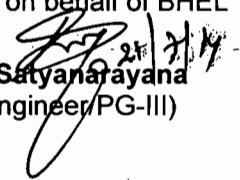
