**13. Delivery Schedule:**

Delivery Schedule for this package shall be –

- a. Delivery shall be Four (04) months from the date of drgs./docs. approval in Cat-I. Drawing/Documents shall be submitted within 15 days from the date of PO and every resubmission shall be done within 7 days, incorporating all the BHEL/ Customer comments. In case there are delays of submission of documents beyond 15 days of order or 7 days of comments, that much days would be reduced from delivery period.
- b. Completion of E&C shall be 3 months from receipt of materials at site or within 3 months from date of site clearance whichever is later.
- c. List of drgs./docs. shall be submitted as per technical specification (Spec. No. : PE-TS-405-557-E001, Rev-01 Section-C, Annexure-3- list of documents & Numbering).

**14. Pre-Qualifying Requirements:**

18. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
