12. Delivery Schedule :-

- (b) Document Submission Schedule: As per "list of documents to be submitted after LOI" SI.No.07 of volume III of Technical specification PE-TS-394-502-A001 (Rev.0). Every resubmission of same shall be done within 10 days of comments and BHEL/NTPC will submit the comments within 21 days. If any delay, it will be attributed to respective accounts.
- (c) Completion of Erection & commissioning will be within Three (3) months from the date of site/front clearance.

The Price shall be Firm till the execution of Project.

13. **Pre-Qualifying Requirements :**

Bidders are requested to furnish the details as per "TECHNICAL, AND FINANCIAL PRE-QUALIFYING REQUIREMENTS" (attached with the enquiry document) and to submit the credentials for their approval.

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements (if, applicable). Credentials of the bidders meeting the prequalifying requirements shall be taken up with customer for approval. Price Bid/RA of only BHEL and customer approved vendors shall be opened/done.

- a) **Approval of bidder by the BHEL** : The bidders which are not registered with BHEL-PEM, refer Supplier Registration Form (SRF) attached with enquiry and submit the same duly filled (with signed & stamped) in along with credentials, experience list, performance certificates and other statutory data with their bids for vendor registration.
- b) **Approval of bidder by Customer** : Approval shall be taken up by BHEL with customer based on the credentials/reference list. Hence Bidders are requested to submit the following (as part of their credentials) on or before technical bid Part-I opening :-
- Reference list indicating PO details, customer name, PO date, execution date etc.
 - Performance certificate issued by the clients.
 - Bidders are requested to fill up their details in NTPC format for Main & Sub – Supplier Questionnaire attached with enquiry) and submit all the supportive documents against details furnished therein.

15. **Indigenous bidders have to quote freight charges in percentage of their quoted Total Ex- works prices.**

16. Bidders to note that Total Erection & Commissioning charges should be minimum 20% of the total Quoted price of the package (Excluding Mandatory Spares price), falling which the break-up of prices Shall be adjusted accordingly for ordering.

18. BHEL reserves the right to go for Reverse Auction (RA) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. . In view of above, bidders are requested to quote their most competitive prices as **no negative price impact** shall be applicable on account of non-conduction of RA. All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'online sealed bid' in the Reverse Auction. Non-submission of 'online sealed bid' by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

Bidders are requested to refer 'Annexure-I to Terms & Conditions of Reverse Auction' enclosed along with tender enquiry.

19. Bidders to quote their import content (CIF), if any in their price bid. BHEL shall inform the availability of CIF value for the package including ceiling limit, if any, during commercial clarification/evaluation of offer.

21. Evaluation will be done on overall L1 (Total cost to BHEL i.e, F.O.R. Site Price for supply plus E&C) basis.
