- 1.1 The tender enquiry No. & due date must be legibly super scribed on the envelope.
- 1.2 Tenders shall be received and opened at BHEL House, Siri Fort, New Delhi on the due date and time as mentioned above in the presence of finance representative and bidders or their authorized representatives who may like to be present.
- 1.3 Tenders should be strictly in accordance with the tender specifications. Any deviation may lead to rejection of tender.
- 1.4 The offers and rates shall remain valid for 30 days.
- 1.5 BHEL shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any tender in part or full without assigning any reason whatsoever.
- 1.6 Tenders received after due date & time are liable to be rejected.
- 1.7 **BHEL reserves the right to increase or decrease the quantity of tentage items by \pm 15% of contract value at the same rates and terms & conditions of this contract.**
- 1.8 Tender should be submitted along with covering letter of the tenderer and each page of the tender document must be stamped and duly signed by tenderer.
- 1.9 **Price quoted by the tenderers will be firm and no escalation on account of labour or material or taxes or any reason whatsoever will be paid to the successful tenderer for execution of the above work.**
- 1.10 Price quoted by the tenderers should be inclusive of all taxes and charges etc. as per Govt. rules and regulations.
- 1.11 **Evaluation of the tenders will be done on the basis of total cost to company. If at any point of time, it is found that the rate quoted against any item is mismatching with amount of the same item or vice versa then the lower value of the two (either rate or amount) will be accepted and total amount of work order will be calculated on the basis of lower value but higher value will be considered for evaluation of bids.**

- 1.12 The total work i.e. preparation of stage, white canats and arrangement of furniture, carpets must be completed in all respect latest by 1000 hrs on 1st Jan 2016.
- 1.13 Penalty @10% of total value of bill will be levied against any delay in completion of work, poor quality of shamiyana/furniture/carpets etc.
- 1.14 BHEL reserves the right to accept or reject any of the bid / all bids with or without deviation or cancel / withdraw the invitation of bid without assigning any reason whatsoever and in such case no tenderer shall have any claim arising out of such action by BHEL.
- 1.15 All documents submitted by the tenderer shall be accompanied with a covering letter with index interlinking all the documents.
- 1.16 Requirements of gas heaters will be confirmed on 30th Dec 2015 and successful party will have to arrange the same as per company requirement.
- 2.0 **Payment terms:**
- 2.1 Full and final payment will be released by BHEL only after successful completion of work. Payment will be released within 20 days approximately after submission of bill through NEFT only, for which party will have to submit its bank details as per requirement after award of work.
- 2.2 Tenderers are requested to go through the complete scope of work as per tender enquiry, visit the site location etc. and get fully acquainted with the work place and prevailing working conditions to get all their doubts, if any, clarified by contact person mentioned below before submitting the offer.
- 2.3 Work order will be placed on the lowest bidder for the complete scope of work.
- 2.4 Penalty will be levied by BHEL as per clause No. 1.13 of this tender enquiry on account of delay, violation of contract conditions or poor quality of tentage items.
- 2.5 As per company policy, no advance will be given to bidders. The payment will be made to the successful bidder after completion of work only and TDS etc. if any, shall be deducted as per income tax act.
- 2.6 In case of arithmetical error, lower rates will be considered for placement of order to party and higher rates will be considered for evaluation of bids.
