(3) QDC fittings - Both male and female- 2 sets.

GENERAL TERMS:

- (a) The DC valve with electrical solenoids should be of 24V, DC (control voltage) and should have light indicator in the plug.
- (b) All the hydraulic components should be of Rexroth / Vickers make only. The pressure gauges with glycerin filled and calibration certificate to be provided along with the supply. Gauge isolators should be provided.
- (c) All the hoses should be of Aeroquip / Gates / Parker make only.
- (d) Accumulator should be of EPE make / equivalent.
- (e) All the components in the circuit should be arranged on the top of the tank except the hydromotor. From the powerpack, only 4 hoses should come out and one hydromotor should be supplied with QDC fittings.
- (f) The pump should be mounted on the top of the tank and should not be immersion type.
- (g) The electric motor should be of NGCEF / KIRLOSKAR / ABB / Siemens. The input supply for power will be of 415V, 3 phase, 3-wire system.
- (h) The power pack is to be painted with 2 coats of Apple green enamel paint. The oil grade and tank capacity is to be painted on the tank.
- (i) The supplier should provide the complete hydraulic circuit with bill of materials giving specification and make of the components used, along with offer for technical assessment.
- (j) In case of ordering, the supplier should provide the complete hydraulic circuit with bill of materials and get them approved before manufacturing.
- (k) The Power pack will be tested and inspected by BHEL personnel at supplier's works before dispatch for performance. The supplier should provide all the test facilities at his works during inspection.


