

(3) Electrical Operating panel:


The movement of cylinder should be operated using the electrical joystick switch mounted on a compact remote operating panel. This operating panel should have the Pump ON/OFF push buttons, Emergency OFF Mushroom button and miniature joystick for operating the 3 position DC valve (inch mode). The operating panel will be mounted near pretension unit and suitable electrical cable with protective conduit should be supplied with the unit.

General Terms:

- (a) The DC valve with electrical solenoids should be of 24V, DC (control voltage) and should have light indicator in the plug.
- (b) All the hydraulic components should be of Rexroth / Vickers / Parker make only. The pressure gauges with glycerine filled and calibration certificate to be provided along with the supply.
- (c) The electric motor should be of NGCEF / KIRLOSKAR / ABB. The input supply for power will be of 415V, 3 phase, 3-wire system. Only 415 V power supply will be provided by BHEL. Suitable transformer is to be provided in the control panel. All electrical wiring is to be provided with proper terminal blocks and terminal numbers.
- (d) The power pack is to be painted with 2 coats of Apple green enamel paint. The oil grade and tank capacity is to be painted on the tank.
- (e) The supplier should provide the complete hydraulic circuit with bill of materials giving specification and make of the components used, along with offer for technical assessment.
- (f) In case of ordering, the supplier should provide the complete hydraulic circuit with bill of materials, electrical circuit, drawings of operating and electrical panel and get them approved before manufacturing.
- (g) The Power pack will be tested and inspected by BHEL personnel at supplier's works before dispatch for performance. The supplier should provide all the test facilities at his works during
