COMMERCIAL TERMS AND CONDITIONS FOR SUBMISSION OF OFFER

1.0 QUOTATIONS

Bidders shall submit the offer in **TWO INNER ENVELOPS** as indicated below which shall be sealed in one outer envelope.

Envelope I This sealed envelope should contain all the copies of technical bid together with un-priced commercial bid. This envelope should be clearly marked "**Part I – Technical and Commercial bid**", indicating enquiry no., due date and address & reference of the bidder.

Envelope II This sealed envelope should contain **price details**. This envelope should be clearly marked "**Part II – Price bid**", indicating enquiry no., due date and address & reference of the bidder.

Both the envelopes (part I & part II) shall be put in one cover, duly sealed, super scribing as part I and part II of enquiry no., due date of opening and the address and reference of the bidder.

The above offer should reach this office on or before the due date by 14.00 hrs (IST). Late offers will not be considered. We suggest you to send the offer by SPPED POST.

Tender should be free from **CORRECTION AND ERASURES**, Corrections if any, must be attested. The following guidelines are applicable for price bid

- a) If, in the price structure quoted for the required material, there is discrepancy between the unit price and the total price (total price is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly
- b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected
- c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above

- d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date upto which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.

Offers should be in **ENGLISH** and accompanied by detailed technical literature, catalogue and details of process facility in **ENGLISH**.

2.0 PART I (TECHNICAL & UNPRICED COMMERCIAL BID)

2.1 Technical

This part shall include / indicate the following:

Offer should contain complete scope of supply with all technical details, specification, delivery and other commercial terms and conditions.

2.2 Commercial

This part shall include / indicate the following;

2.2.1 Part of shipment / station of dispatch

2.2.2 Terms of payment

2.2.3 Taxes & duties applicable

2.2.4 Delivery schedule

2.2.5 Offer validity

2.2.6 Country of origin

2.2.7 A copy of "Un-Priced Part II" i.e., a copy of the price bid without **the price details** to be enclosed.

3.0 PART II (PRICE – BID)

This part should contain the schedule of price particulars and to be co – related to the technical details provided in part wherever required / possible break up price details are to be furnished. (Bidders shall quote only fixed rate / price only and not subject to any escalation whatsoever during the period of bid validity and execution of purchase order. Any bid with adjustable or price variation clause shall be treated as "non-responsive" and liable for rejection).

4.0 OPENING OF TENDERS

The part I – Technical & commercial bid alone would be opened on the tender opening date at the pre-fixed time in presence of responded tenderers / authorized representative, who may like to be present for tender opening.

The part II – Price bid of technically suitable bidders alone would be opened. The technically suitable bidders would be informed about the price bid opening date. Clarifications if any required by BHEL for technical evaluation would be sought from bidders before opening of part II – price bid.

5.0 GENERAL

5.1 Incomplete offers will not be considered.

5.2 Terms of Delivery: Bidders are required to quote their best delivery period. Delivery shall be counted from the date of letter of intent.

5.3 Taxes and Duties: All taxes and duties if any payable extra over and above the quoted price should be specifically indicated in the un-priced bid along with CST & TIN No etc., failing which the purchaser will not be liable for payment of such taxes and duties.(the quoted rates shall be considered as "all inclusive"

5.4 validity of offer: Offer shall be kept valid for acceptance for a period of 90 days (ninety days) from the date of bid opening.

5.5 Payment terms: Payment term is 100% direct payment after 45 days from the date of receipt and acceptance of materials (Any deviation in the above payment term will attract loading as mentioned below)
"Base rate of SBI (as applicable on the date of Techno-commercial bid opening + 6% will be loaded for the period of relaxation sought by bidders).

Payment through bank is not preferred. In case of payment through bank is opted by the supplier, BHEL prefers documents submission through bank with copy of LR and door delivery of Goods to stores with consignee copy attached. In this case loading will be 3% on the offered value.

5.6 Liquidated Damages: It is clearly understood among the parties to the contract the "**Time is the essence of the contract**". Therefore, the delivery of the goods specified in the purchase order should be made within the time prescribed. Failure to dispatch the materials in the time as per the delivery quoted in our purchase order would make the supplier liable to an un-conditional penalty as below.

a. Liquidated damages shall be 0.5% of the total order value per week or part there of subject to a maximum of 10% of the total order value

b. For staggered delivery schedule, LD shall be 0.5% of the undelivered portion per week of the delay or part there of subject to a maximum of 10% of the total order value.

c. Any deviation from the above LD clause, loading will be applied to the extent to which it is not agreed by the bidder (at offered value)

5.7 Risk Purchase: Alternately the purchaser at his option will be entitled to terminate the contract and to purchase elsewhere at the risk and cost of the seller either the whole of the goods or any part which the supplier has failed to deliver or dispatch within the time stipulated as aforesaid or if the same were not available, the best and the nearest available substitute therefore. The supplier shall be liable for any loss, which the purchaser may sustain by reason of such risk purchases.

5.8 Test Certificates: The bidders shall clearly mention in their offer that test certificate as called for in the technical specification, in the required number of copies will be provided at no extra cost.

5.9 Evaluation of the offers shall be on the basis of "to-Door cost at BHEL, Trichy" (Net cash outflow to BHEL). BHEL will consider the ranking after the loading is applied as offered above wherever deviations are observed.
