A) GENERAL CRITERIA FOR EVALUATION

1. Bidder should be a primary producer of steel or their approved re-roller.
2. Bidder should have in-house manufacturing facility of MS rods (as per IS:2062 Grade-A or SAE-1010/1018/1020).
3. Vendor should have capability of manufacturing MS rods of about 500 MT per month.
4. Primary producer of steel should have in-house capability to carry out all applicable tests as per relevant standards.
- 5a. Supplied MS rods greater than 30 mm dia. to 2 different end users.
OR
- 5b. Repeat order received from 2 different end users for MS rod during last 5 years provided the gap between award of two PO's is minimum 3 years.
OR
- 5c. 1 no. supply experience (as per sl. no. 5a) and 1 no. repeat order (as per sl. no. 5b).

Notes :

- i. Vendor(s) not registered with BHEL-PEM Noida for 'MS rods' shall submit relevant documents in support of above mentioned General Criteria.
- ii. For registration of additional works by a vendor already registered with BHEL-PEM Noida for 'MS rods', vendor shall submit relevant documents in support of sl. no. 2 & 3 of the above mentioned General Criteria for the proposed additional works.

B) PROJECT SPECIFIC CRITERIA AGAINST ENQUIRY

1. Bidder(s) already registered with BHEL-PEM Noida for 'MS rods' need not submit credentials for General Criteria indicated above.
2. After satisfactory fulfilment of all the above criteria/ requirement, offer shall be considered for further evaluation as per NIT and all the other terms of the tender.


