BHEL has now made arrangements for payment of EMD thru' Online. The steps to make online payment is detailed as below:

- 2) Click 'Proceed' button
- 3) Select '**Tamilnadu**' in the drop down menu under 'State of Corporate/Institution \*\*'
- 4) Select '**PSU-PUBLIC SECTOR UNDERTAKING**' in the next drop down menu under "Type of Corporate/Institution"
- 5) Click 'Go' button
- 6) Select '**BHEL BAP RANIPET**' in the drop down menu under "PSU-PUBLIC SECTOR UNDERTAKING"
- 7) Click 'Submit' Button
- 8) Select '**EMD**' in the drop down menu under 'Select Payment Category'
- 9) Now Fill in the required details and ensure correctness of data filled. Ensure that you are entering correct enquiry/tender number and other details correctly.
- 10) Make payment for EMD as required in tender after entering the details and enclose copy of receipt along with tender documents. Scan and upload the receipt document in case of tender under e- procurement mode.

The above facility is in addition to the existing method of remitting by DD.

In page no.14/74, the minimum number of vehicles owned is modified as 26 as below;  
Minimum number of vehicles owned by the bidder.

The bidder shall own the following number of vehicles to get qualified in this tender:

- (i) Minimum number of Trailers (capacity of 20 MT and above up to 32 MT) owned by the bidder : 26 (Copy of R.C.Book (self attested) first page mentioning name of vehicle owner to be submitted)
- (ii) The carriers who are owning 26 or more trailers in the name of their company (public limited/private limited company) or in the name of partners ( in the case of partnership firm) or in the name of proprietor( in the case of sole proprietorship) only are eligible to participate in the tender.
