ELIGIBILITY CRITERIA:

- 2) Average annual turnover of similar works in the last three financial years should be 30 % of the value of work indicated above.
- 3) During last seven years should have successfully completed works either
 - i) Three similar works each not less than 40 % of value of respective work or
 - ii) Two similar works each not less than 50 % of value of respective work or
 - iii) One similar work not less than 80 % of value of respective work
- 4) Solvency certificate shall be minimum of 40 % of value of respective works indicated above
- 5) Should have valid electrical license for Sl.No.02

Note:- CONTRACTORS WHO HAVE REGISTERED IN BHEL, TIRUCHY UNDER RESPECTIVE CATEGORY WITH REQUIRED MONEY LIMIT FOR THE SAID VALUE NEED NOT SUBMIT THE DOCUMENTS CALLED FOR IN THE QUALIFICATION BID. HOWEVER THEY HAVE TO SIGN AND SUBMIT THE QUALIFICATION BID ALONG WITH THE PRICE BID.
