3. Ref. clause at Sl.No.3 of Enquiry letter: - Annexure I and Annexure II to GCC Rev 04 shall be read as Annexure I and Annexure II to GCC Rev 05.
4. Ref. clause at Sl.No.15 of Enquiry letter: - Clause No.15 of NIT shall be read as Payment terms for the supply portion will be as per GCC, Rev 05, General Commercial Terms and Conditions: cl no: 9.2.

5. **Ref. clause at SI.No.17 of Enquiry letter:** - Clause No.17 of NIT shall be read as "BHEL/ PEM reserves the right to go for Reverse Auction, through BHEL appointed service provider, instead of opening sealed price bids submitted along with Part-I. This would be decided after techno-commercial evaluation. (Refer Clause No. 15.0 of Instruction to Bidders, GCC REV 05).
6. **Ref. clause at SI.No.22 of Enquiry letter:** Clause No.22 shall be read as Bidder has to submit "NO DEVIATION CERTIFICATE FOR COMMERCIAL TERMS AND CONDITIONS AS PER GCC (05), SCC (REV00) AND NIT". In case of deviations, bidder to clearly mention the same with their techno-commercial offer.
7. **Ref. clause at SI.No.27 of Enquiry letter:** The word GCC Rev 04 shall be read GCC Rev 05
8. In the Price Schedule for Plate Heat Exchangers it was mentioned that for Foreign Bidders, additional loading of 4% against LC will be done. Loading as per GCC (Rev 05) will supersede the said loading through LC.

However, Bidders must refer to GCC, Rev.05 for other terms & conditions which supersedes the terms & conditions of GCC (Rev 04) mentioned in the NIT.
