TERMS & CONDITIONS OF TENDER:

PART 'A' – TECHNO- COMMERCIAL BID

A. INSTRUCTIONS FOR THE BIDDERS:

1. The offer shall be submitted as per the instructions of tender document. Only one set of tender document from each bidder duly signed & stamped on each page shall be submitted. Tenderer should note that complete tender document shall be submitted by them (after signing/ stamping on each page) as a part of their offer. Price shall not be mentioned by them anywhere in the techno-commercial portion of offer, except in the relevant price bid which must be submitted in separate sealed envelope. In case of any clarification, bidder may contact this office.
2. Tender documents are also available on BHEL web site (www.bhel.com) & on CPP Portal (<http://eprocure.gov.in/cppp/>) which can be downloaded and used as tender document for submitting the bid.
3. No overwriting / correction in tender documents by tenderer shall be allowed. However if correction is unavoidable, the same must be duly countersigned by the bidder.
4. The tenderer must submit their tenders in two separate sealed envelopes prominently super scribed as Part – A 'Techno- commercial bid' and Part-B 'Price Bid' along with NIT No. & due date written on each of the envelope. These two separate envelopes shall together be kept in third envelop super scribed as "Tender for renewal of IGL gas pipelines".
5. Techno-commercial bid (Part A) should contain all the documents mentioned in PQR at page No.3, Sl. No. B – a to j and complete tender document except price bid signed by the bidder in one envelope marked as Part A.
6. Duly filled Price Bid should be kept separately in 2nd envelope, marked as "Part-B.
7. Now both the above envelopes must be kept in third sealed envelope, marked as "Tender for renewal of IGL gas pipelines".
8. The tenderer shall submit the Bank details along with a cancelled cheque for payment through NEFT/RTGS.
9. Rates quoted must be inclusive of taxes and all the charges applicable. No additional payment other than quoted in price bid will be made by BHEL.
10. On the date of opening of tender, only Techno-Commercial Bid shall be opened. Subsequently, evaluation of bids will be done as per tender terms & conditions. Price bids (Part B) of techno commercially qualified parties only will be opened.

B. PRE QUALIFYING REQUIREMENTS (PQR):

- a) The bidder shall submit the complete tender document in all respects duly signed & stamped on each and every page as a token of acceptance of all the terms and conditions of tender.
- b) The bidder should submit self-attested copy of PAN Card.
- c) Bidder should submit self-attested copy of Service Tax Registration certificate.
- d) The bidder's average annual financial turnover should be Rs.71, 000.00 or above for the last 03 financial Years. In this regard, self-attested copies of balance Sheet/Profit & Loss Account Certified by CA / copies of Income Tax return of last three financial years are to be submitted.
- e) Self-attested copies of Work Orders/ Award letters/ Contract Agreement in support of proof of experience for the similar works executed by the bidders during last 7 years. The value of work experience should be as follows:
 - i. Three similar jobs/ services/works costing not less than **Rs.94000/-** each.

GENERAL TERMS & CONDITIONS:-

- 1.1 The tender enquiry No. & due date must be legibly super scribed on the envelope.
- 1.2 Tenders shall be received and opened at BHEL House, Siri Fort, New Delhi on the due date and time as mentioned above in the presence of finance representative and bidders or their authorized representatives who may like to be present.
- 1.3 Tenders should be strictly in accordance with the tender specifications. Any deviation may lead to rejection of tender.
- 1.4 The offers and rates shall remain valid for 60 days from tender opening date.
- 1.5 BHEL shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any tender in part or full without assigning any reason whatsoever.
- 1.6 Tenders received after due date & time are liable to be rejected.
- 1.7 **BHEL reserves the right to increase or decrease the quantity by \pm 15% of contract value at the same rates and terms & conditions of this contract.**
- 1.8 Tender should be submitted along with covering letter of the tenderer and each page of the tender document must be stamped and duly signed by tenderer.
- 1.9 **Price quoted by the tenderers will be firm and no escalation on account of labour charge, material or any other reason whatsoever will be paid to the successful tenderer for execution of the above work.**
- 1.10 Price quoted by the tenderers should be inclusive of all taxes and charges etc. as per Govt. rules and regulations.
- 1.11 **Evaluation of the tenders will be done on the basis of total cost to company. If at any point of time, it is found that the rate quoted against any item is mismatching with amount of the same item or vice versa then the lower value of the two (either rate or amount) will be accepted and total amount of work order will be calculated on the basis of lower value but higher value will be considered for evaluation of bids.**
- 1.12 Complete work of laying and fixing of pipelines must be completed within two weeks' time from the date of release of Work Order and all the items supplied must be strictly as per specification mentioned in price bid format.
- 1.13 **Penalty @10% of total value of bill will be levied against any delay in completion of work and poor quality of items/workmanship.**
- 1.14 BHEL reserves the right to accept or reject any of the bid / all bids with or without deviation or cancel / withdraw the invitation of bid without assigning any reason whatsoever and in such case no tenderer shall have any claim arising out of such action by BHEL.

2.0 **Payment terms:**

- 2.1 Full and final payment will be released by BHEL only after successful completion of complete work. Successful completion of work means handing over of 'SAFE' certificate, issued by the PNGRB authorized "Third Party Inspection Agency" after laying & fixing of gas pipelines. Payment will be released within 20 days approximately after submission of bill through NEFT only, for which party will have to submit its bank details as per requirement after award of work.
- 2.2 Tenderers are requested to go through the complete scope of work as per tender enquiry, visit the site location etc. and get fully acquainted with the work place and prevailing working conditions to get all their doubts, if any, clarified by contact person mentioned below before submitting the offer.
- 2.3 Work order will be placed on the lowest bidder for the complete scope of work.
- 2.4 Penalty will be levied by BHEL as per clause No. 1.13 of this tender enquiry on account of delay & violation of any contract conditions.
- 2.5 As per company policy, no advance will be given to bidders. The payment will be made to the successful bidder after completion of work only and TDS etc. if any, shall be deducted as per income tax act.
- 2.6 In case of arithmetical error, lower rates will be considered for placement of order to party and higher rates will be considered for evaluation of bids.

3.0 **SCOPE OF WORK:**

- 3.1 As per Price Bid Format enclosed at **Annexure – A1**
- 3.2 The scope of work consists of supply, laying, fixing of IGL standard gas pipelines up to the burner with required accessories of brand mentioned in 'Annexure A1'. It is also the responsibility of successful bidder only to get the third party inspection done as per IGL guidelines and hand over the 'Third Party Inspection' certificate to BHEL. The successful bidder has to make complete structure of gas pipelines with accessories ready in all respect for release of gas connection by IGL.
