Corrigendum for correction in Tender Document of Power Transformer End Frame, E3559002

We have issued Open/Press tender for Power Transformer End Frame E3559002 dated 25.01.2016 with due date of 26.02.2016 13:15 HRS.

The tender is for “FRAME WORK AGREEMENT (Rate Contract) FOR SUPPLY OF Power Transformer End Frame ON FINISH BASIS FOR TWO YEARS”, but inadvertently at clause H1 of Schedule VI it has been written that

“Validity of the rate contract shall be one year from the date of finalization for ordering & 3 months thereafter for supply. However R/C can be extended for further one more year on mutual consent.”

Instead of

“Validity of the rate contract shall be two year from the date of finalization for ordering & 3 months thereafter for supply.”

To incorporate this change in the tender document we have issued corrigendum for the tender E3559002.
