**Query 01:** Refer Clause No. 18.15 in Chapter No. XVIII, of Vol IA 'TCC': Please clarify whether the manpower indicated in the clause is the total requirement or per shift requirement. Also clarify that, if the requirement increases, BHEL whether BHEL will compensate the contractor and if it is unutilized, there will be deduction in payment.

**Clarification 01:** This is only tentative requirement of manpower for balance commissioning activities after the start of commercial operation. However actual requirement of skilled/semi-skilled manpower will be based on actual site requirement & will be deployed as per instruction of BHEL site in-charge. There will be no additional payment/deduction envisaged on this account.
