COMMERCIAL TERMS & CONDITIONS

Clause No.

6. PAYMENTS FOR LOCAL JOURNEYS: The payment for local journeys will be regulated on the following basis:

- a) **For journeys up to 40 KMs & 4 hrs :** The payment will be regulated on the itemized rates finalized of the Price Bid.
- b) **For journeys beyond 40 KMs and up to 80 KMs & beyond 4 hrs and up to 8 hrs. :** The payment for the journeys beyond 40 KMs and up to 80 KMs and beyond 4 hrs and up to 8 hrs., will be regulated on the itemized rates finalized for 40 KMs & 4 hrs of the Price Bid. In addition, the amount payable for extra KM charges & extra hour charges will be calculated and payment will be made.
- c) **For journeys beyond 80 KMs & 8 hrs :** For the journeys beyond 80 KMs & 8 hrs., the payment will be regulated on the itemized rates finalized for 80 KMs & 8 hrs of the Price Bid. In addition, the amount payable for extra KM charges & extra hour charges will be calculated and payment will be made.

Shall be read as:

6. PAYMENTS FOR LOCAL JOURNEYS: The payment for local journeys will be regulated on the following basis:

- a) **For journeys up to 40 KMs & 4 hrs :** The payment will be regulated on the itemized rates, A1, finalized of the Price Bid.
- b) **For journeys beyond 40 KMs and up to 80 KMs or beyond 4 hrs and up to 8 hrs. :** The payment for the journeys beyond 40 KMs and up to 80 KMs and beyond 4 hrs and up to 8 hrs., will be regulated on the itemized rates finalized for 40 KMs & 4 hrs of the Price Bid. In addition, the amount payable for extra KM charges & extra hour charges will be calculated and payment will be made. In any case, the payment cannot exceed item A2, if the distance is less than 80KMs or time is less than 8Hrs.
- c) **For journeys beyond 80 KMs or beyond 8 hrs :** For the journeys beyond 80 KMs or beyond 8 hrs., the payment will be regulated on the itemized rates, A2, finalized for 80 KMs or 8 hrs of the Price Bid. In addition, the amount payable for extra KM charges & extra hour charges will be calculated and payment will be made.


21. Parking charges, Toll tax, Service Tax and DND payments, as applicable from time to time shall be extra and borne as per actuals by BHEL on submission of documentary proof (original receipt). No other tax, including Inter State Passenger tax, shall be reimbursed by BHEL on NCR journey.

Shall be read as:

21. Parking charges, Toll tax, Service Tax and DND payments, as applicable from time to time shall be extra and borne as per actuals by BHEL on submission of original receipt. In case of hiring of commercial vehicles for use on Daily/Monthly basis, state entry taxes (excluding Delhi & UP), without service tax, shall also be payable at actuals against production of documentary evidence. No other tax shall be reimbursed by BHEL on NCR journey.

Note: 1) This revised clause 6 & 21 shall be superseding the relevant notes of annexure 'G'.

2) Item description A2 'Beyond 80KMs and 8HRs' of Price BID shall be read as 'Beyond 80KMs or beyond 8HRs'.
