Subject: Annual Contract for the supply of meat (He goat) for the year 2013-2014. Terms & Conditions are as follows.

1. Firm/Shop of meat (He goat) supply should be license holder/duly registered.(photo copy to be enclosed along with tender)
2. Supplied meat (He goat) should be fresh and of good Quality.
3. The meat should be dry cut & should not be wet in the water.
4. Supply of meat (He goat) will be on weekly basis on every Wednesday upto 09:00 AM Charges for supply shall be borne by the supplier.
5. No payment shall be made for vehicle, labour, Taxes etc. All above expenses are to be included in the rates quoted for the meat (He Goat).
6. Meat (He goat) shall be supplied for additional working days/programs in canteen. Quantity can be increased or decreased.
7. 30 pieces of meat should be in one kg weight.
8. Order for the supply of meat (he goat) shall be taken by the Supplier from Canteen in one day advance.
9. For ensure the quality of meat our representative will be casually visit and check that the Meat is healthy goat. So the indicate the time and place of Slaughter house (Vadhshala).
10. Payment of supplier shall be made on monthly basis through cheque /e-Payment for which you have to submit required document for e- payment.
11. Supplier shall enclose demand draft/Banker's cheque for Rs.20,000/-in favour of BHEL JHANSI towards EMD. Along with the technical bid. EMD shall be adjusted against Security deposit. If tender is not accepted then this money shall be refunded to the supplier after needful action at BHEL's end. If EMD is not submitted along with technical bid tender shall not be accepted.
12. On the receipt of order, suppliers shall deposit 10% money as a security deposit in the form of DD/Banker's cheque. This money shall be refunded to the supplier after completion of contract satisfactory. EMD shall be adjusted against security deposit.(SD shall be as per works policy-2008)
13. Supplier shall deposit necessary stamp duty on security deposit as per govt stamp act.
14. This Contract shall be applicable for one year but management has full right to cancel the contract before the completion of contract i.e. one year.
15. Management can cancel tender without giving any reason.

16. Deviation from above conditions or supply of bad quality of meat (He Goat), untimely supply of meat (He Goat), than alternative arrangement will be made & the payment will be deducted from supplier's bill / EMD for the same.
17. In the beginning supply order shall be valid for one month if found satisfactory it will be extended for whole year.
18. This tender will be in two bid system.
19. The consumption of meat will be approx 30-50 kg/week.
