c). Reverse Auction (RA):

All bidders to give their acceptance for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

In case BHEL decides to go for Reverse Auction, only those bidders who have given their acceptance to participate in RA will be allowed to participate in the Reverse Auction. Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit „online sealed bid“ in the Reverse Auction. Non-submission of „online sealed bid“ by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.

5.0 MANUFACTURE:

The low density polyethylene shall be manufactured from compound having polyethylene resin with additives to impart the additional qualities to the film such as slip, antioxidant, low water permeability, dust protection, transparency etc.

“BHEL” emblem of size A40 shall be embossed at an interval of 500mm along the length of film and 250 mm along it’s width. The colour of emblem shall be Air Craft Blue (Shade No.108) as per IS:5.

6.0 APPEARANCE AND FINISH:

The film shall be uniform in colour, texture and finish. And also shall be free from pinholes, undispersed raw material, streaks, foreign particles holes, and tears or blisters. The edge shall be free of nicks and cuts when seen with unaided eye.

7.0 COLOUR:

Unless otherwise specified, the film shall be supplied in natural colour (essentially colourless). Black colour or any other colour can also be ordered.

7.0 ODOUR:

The film shall be free from any objectionable odour.
