4	Evaluation	On the basis of total landed cost to BHEL, CSU, Stores, Jagdishpur inclusive of loading, if any
5	Terms of Payment	i) 100% payment within 30 days after receipt & acceptance of material at BHEL Jagdishpur through E-payment. ii) Original excise duty gate pass shall be submitted by the vendor to enable purchaser to claim Cenvat credit (if applicable).
6	Validity of offer	Offer validity will be for 90 days from date of opening of Tender enquiry.
7	Penalty for Delay	The delivery of material shall be made within the time prescribed.
