19. Indian bidders to note that the Freight charges that is to be quoted by you shall be in percentage of the Total Ex Works. Bidder to mention the percentage of freight (of Total Ex Works).

22. Construction power & Construction water will be provided free of cost at one point and further distribution by the contractor. Storage space will be provided free of cost for storing materials however contractor has to arrange his own labour colony. Storage shed to be constructed by bidder.
