- 1.3 Polythene wrapper shall be used for covering the jobs/machine while packing inside the boxes/crates
- 1.4 The thickness of the plank should be a finished size & not a commercial size. 1" should measure 22 mm min., 1.5" should measure 34 mm min.,2" should measure 45 mm min. & this should be clearly indicated in the offer.
- 1.5 offer should be quoted Separately for box/crate(Inside size) & block/plank(outside size) Formula of cubic feet is given below:-


