- The bidders should have executed material handling works like loading and unloading of heavy equipments for any power plant with a unit capacity of **110 MW** and above or handling of heavy equipments / components of industries such as Petro Chemicals, Steel plants, Refineries , Fertilizer Plant in the last seven years
- The bidders should have a minimum average financial turn over of **Rs.48 Lakhs** per year in the preceding three years ending 31st March 2008.

The Bidder must have earned profit in any one of the last three financial years ending 31.03.2008 and should have positive net worth as on 31.03.2008.

Bidder should submit audited balance sheet and profit & loss account of the company for last three years ending 31.03.2008 in support of above requirement.
