16. PRE-QUALIFICATION REQUIREMENT :-

All the bidders (except BHEL-PEM registered without any technical limit) are required to submit Technical Pre-Qualification Requirement along with their offer. Only those bidders, who fulfil these requirements, shall be eligible to participate in this tender.

All the bidders (except BHEL-PEM registered without any financial limit) are required to submit Financial Pre-Qualification Requirement along with their offer. Only those bidders, who fulfil these requirements, shall be eligible to participate in this tender.

Bids of only those bidders shall be evaluated who meet the Technical as well as Financial pre-qualifying requirements. Credentials of the bidders meeting the prequalifying requirements shall be taken up with customer for approval. Price Bid/RA of only BHEL and customer approved vendors shall be opened/done.

17. Bidder to note for compliance that this is conditional enquiry, the price bid (Part-II) opening/RA is subjected to

a) Approval of bidder by the BHEL.

- The vendors which are not registered with BHEL-PEM have to download the Supplier Registration Form (SRF) from www.bhel.com after viewing PQR requirement on www.bhelpem.com and submit the same duly filled in along with credentials – experience list, performance certificates and other statutory data with their bids for vendor registration.

b) Approval of bidder by Customer. Same shall be taken up by us with customer based on the credentials/reference list. So you are requested to submit all the documents required as per Financial ,Technical PQR and following upgrading on or before technical bid Part-I opening :-

- Reference list indicating PO details, customer name, PO date, execution date etc.
- Performance certificate issued by the clients.
- Vendor to submit the Main & sub-supplier questionnaires as per the format enclosed.

18. During price evaluation in case of foreign currency bids, exchange rate (TT selling rate of State Bank of India) as on schedule date of tender opening (part I bid in case of two part bids) will be considered for conversion in Indian Rupees.
