Bids will be opened at 3 p.m. on the due date in the presence of bidders who may like to be present.

GENERAL

3. Prices shall be net F.O.R. destination inclusive of freight, handling and packing charges, transit insurance etc. and remain valid for 2 months from the due date.
4. Taxes and duties payable should be indicated separately, otherwise it will be presumed that the goods quoted are inclusive of all taxes, duty, octroi etc., if any and BHEL in such cases shall not pay any tax, duty, octroi etc..
5. No revision of prices shall be entertained after bids have been opened.
6. PRICES shall remain FIRM without any variation till completion of contract.
7. Manufacturer's name, trade Mark or Patent No., if any, should be specified.
8. Illustrative leaflets giving technical details of items offered should be enclosed, wherever necessary.
9. Products with I.S.I. certification marks will be preferred.
10. BHEL shall be under no obligation to accept the lowest or any other bid and shall have the right to accept or reject any bid in part or in full without assigning any reason whatsoever.

14. **PACKING AND MARKING** : vendor shall arrange for sound packing and marking the goods to avoid any loss or damage during transit.

16. **SUBMISSION OF INVOICE** : All Invoices along with specified documents shall be submitted in triplicate, to CMM/LP Deptt. of BHEL/PEM, Noida.

However, if accepted, Liquidated Damages at the rate of half percent per week of delay or part thereof shall be levied on the value of goods delayed limited to ~~five~~ 10 percent of the total contract value, without prejudice to any other relief or compensation due to the Purchaser under any other condition of the Purchase Order.
18. **RISK PURCHASE** : Purchaser will have the option to terminate the contract and purchase from elsewhere at the risk and cost of the Vendor, either the whole or part of the goods which the Vendor has failed to deliver or despatch within the stipulated delivery period or if the same were not available, the best and the nearest available substitute thereof. The Vendor would be liable to compensate the Purchaser for any loss which the Purchaser may sustain by reason of such risk purchase, in addition to Liquidated Damages at the rate mentioned above.
19. **NOT APPLICABLE**

A) GENERAL REQUIREMENTS

1. The intent of the specification is to define the functional & design requirements for the CCTV System meant for augmenting and strengthening the security system at our office (BHEL-PEM) premises. This is required for safe and smooth working in our office premises. In this regard, it is proposed to install CCTV camera at PPEI building, MPL block, Civil, Electrical building, Server room and IT Equipment storage area.
2. The Bidder shall be responsible for selection, design, installation and commissioning of the system to the satisfaction of BHEL. All the cables, power packs, erection hardware etc. are also included in bidder's scope.
3. The CCTV System offered by the Bidder shall be of the make as specified in Technical requirements.
4. The quantity of items is listed in the BOM. Any other item required for system completeness shall be in Bidder's scope.
5. Warranty/guarantee of minimum of 2 year is required.

B) SCOPE

1. Complete erection/installation, commissioning & handing over within 4 weeks is in bidder's scope.

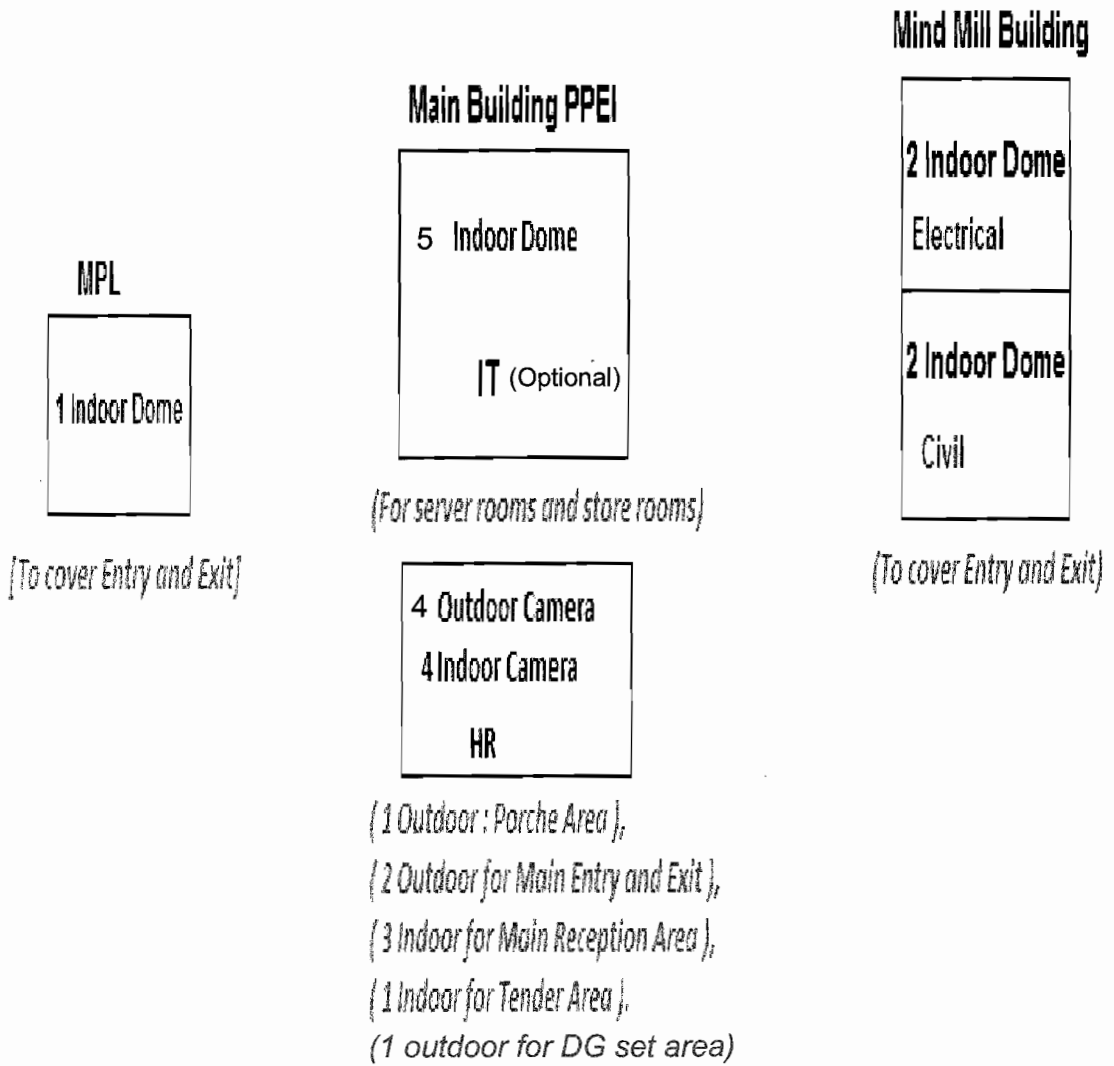

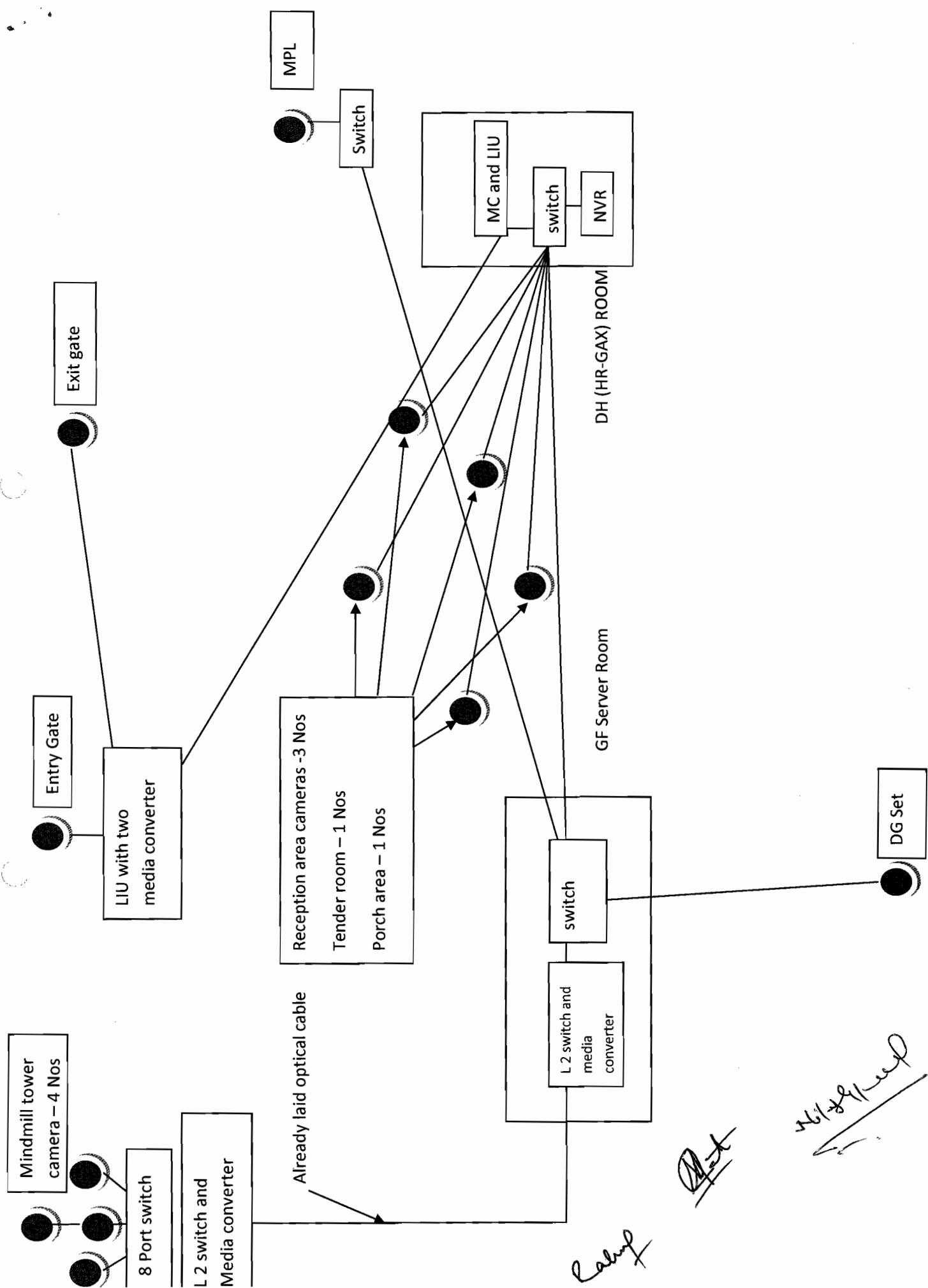
SOLUTION LAYOUT
