2.0 EVALUATION OF TENDER AND AWARD OF WORK:

BHEL will constitute two committees viz Purchase Committee for Techno-commercial & Price evaluation of the bids and Screening/ Selection committee for functional evaluation of the samples received (as per notified criteria at clause 2.1.2 of this annexure).

The process of evaluation is detailed hereunder:

2.1 Techno-Commercial Evaluation

- 2.1.1 Purchase committee will scrutinize the Techno-commercial bids submitted by bidding agencies based on Pre-Qualification Requirement as per clause 1.0 above and recommend techno-commercially qualified suppliers to Screening/ Selection Committee for functional evaluation of the samples received.
- 2.1.2 Samples of the compliant bidders will be displayed to the Selection Committee for their functional evaluation/selection/scrutiny. The committee will evaluate the samples by assigning scores based on the following parameters:
- Features Specifications : 70 % Weightage
 - Design & Aesthetics : 10 % Weightage
 - Manufacturer's warranty : 20 % Weightage (Sample with maximum Manufacturer's warranty would be assigned maximum marks and rest of the samples would be assigned score for 'Manufacturer's warranty' parameter on pro-rata basis)
- 2.1.3 Technical committee to recommend list of samples along with bidder names which scored more than 70% in Technical Evaluation for Price Evaluation by Purchase Committee.

2.2 Price Evaluation

- 2.2.1 The Purchase committee will then open price bids for the short-listed samples as proposed by the Selections Committee
- 2.2.2 Evaluation of the L1 bidder shall be done on the basis of amount quoted against S. No. 5 & 6 of the Price Proforma. Award of work will be on the basis of lowest amount quoted by the compliant bidder. Order shall be placed on the L1 bidder.

2.2.3 Variation in quantities beyond specified for each product will be governed by the Unit rates quoted.

3.0 SAMPLES

- 3.1 Physical sample for which offer has been submitted, duly affixed with sticker as per details at Annexure – II should be submitted along with the Part – I of the offer. Offers without a physical sample will not be considered.
- 3.2 Samples submitted shall be returned after finalization of the purchase orders.

4.0 DISPATCH

- 4.1 The vendor shall be responsible for dispatches of the ordered quantity to BHEL office at '**Jeevan Tara Building, 5 Sansad Marg, New Delhi – 110 001**'. Dispatches to be carried out by the successful bidder at no extra cost, through its own arrangements, the price quoted should be inclusive of the same including charges towards labor deployed for loading on the trucks/ vehicles & handling, etc.

5.0 DELIVERY SCHEDULE

- 5.1 Delivery Schedule is given in enclosed Annexure-V, which has to be strictly adhered to.

6.0 WARRANTY

- 6.1 In case of non-adherence to the specifications as given in the enclosed Annexure – I of Specifications/ Scope of Work with respect to approved samples or manufacturing defects/ non-functionality of the items supplied, as applicable, bidders are liable for free replacement of the goods within the warranty period specified.

7.0 PENALTY – DELAY

- 7.1 The delivery schedule given at Annexure-V will have to be strictly adhered to.
- 7.2 **Any delay beyond specified schedule for completion of delivery will invite imposition of penalty at the rate to be determined by BHEL.** BHEL reserves the right to refuse to accept delivery after the event.

8.0 RISK PURCHASE

- 8.1 BHEL at its option will be entitled to terminate the contract and get the job done elsewhere at the risk and cost of the bidder either the whole of the goods or part thereof which the bidder has failed to deliver within the stipulated time as aforesaid or if the same are not available, with the best and the nearest available substitute thereof.



8.2 The bidder shall be liable for any loss which BHEL may sustain by way of such risk purchases, in addition to penalty at the rate mentioned in Clause 8.0 above.

9.0 QUERIES OF BIDDERS


9.1 Bidder(s) are required to send their queries, if any, in writing/via email at least 3 days ahead of the date of submission of bids.

10.0 EXPENSES TO BE BORNE BY BIDDERS

Annexure IV

GENERAL TERMS AND CONDITIONS

1.0 SUBMISSION OF OFFER

- 1.1 Your offer should be complete in all respects (refer Annexure IX).
- 1.2 Offer should be either typed or written legibly in English. Alterations/ over-writings, if any, in the tender should be attested by the person signing the tender. Tenders with alterations etc. not authenticated as above may be rejected by BHEL.

2.0 PRICE

- 2.1 Price quoted as per price bid format should be firm. No increase in rates will be allowed once the bids are opened and the same will remain valid for the entire period of this contract.
- 2.2 Price to be filled in as per the Price Proforma (Annexure VI). Change in Price Proforma is not allowed.
- 2.3 All prices should be inclusive of all taxes and duties, etc., as applicable except service tax in case applicable. Service Tax portion should be indicated separately in the place provided in the Price Proforma (Annexure VI).
- 2.4 If, in the price structure quoted for the items, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- 2.5 If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected.
- 2.6 If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (3.4) and (3.5) above.
- 2.7 If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.
- 2.8 Offers not fulfilling any of the above conditions are liable for rejection.

3.0 VALIDITY OF OFFER

- 3.1 Your offer shall be valid for a period of 90 days from the date of opening of the Bid

4.0 TAXES

- 4.1 It is mandatory to comply with all taxes applicable for the required services. Your price should be inclusive of all taxes, duties and levies except Service Tax.

However, the amount towards Service Tax should be indicated separately in the specified place in Price Proforma enclosed as Annexure –VI.

5.0 PRICE ESCALATION CLAUSE

- 5.1 All the prices quoted by the bidders shall be in Indian Rupees and shall be final and binding and not subject to any price escalation.

6.0 TERMS OF PAYMENT

- 6.1 100% payment shall be made within 30 days from the date of receipt of bills duly supported with the acknowledged copies of challans for receipt of quantities in good conditions. All payments shall be subject to Statutory Deductions as per norms.
- 6.2 BHEL reserves the right to make payment through E-mode. Successful supplier shall be required to furnish the following information upon selection on its letter head as per Annexure XI.

7.0 LATEST UPDATES

- 7.1 All corrigenda, addenda, amendments, time extensions, correspondences, clarifications, changes, errata, revisions etc. to the tender will be hosted on the websites (www.bhel.com and <http://eprocure.gov.in>) only and not in newspapers. Bidders should regularly visit the websites till the date of submission of the bids to keep themselves updated.

8.0 ARBITRATION

- 8.1 Any dispute or difference, whatsoever arising between the parties out of or relating to the construction, meaning and operations or effect of this contract or breach thereof shall be referred to the sole arbitration of the Head of Corporate Communication of BHEL whose decision shall be final, conclusive and binding on the parties. The arbitrator shall give reason (s) for the award.
- 8.2 Subject to the above, the provisions of Arbitration Act 1996 and the Rules made there under shall be deemed to apply to the arbitration proceedings under this clause.

9.0 EFFECT AND JURISDICTION OF CONTRACT

- 9.1 The law applicable to this contract shall be the laws in force in India. The courts in Delhi, India, shall have exclusive jurisdiction in all matters arising under and on account of this contract.

- 11.1 Incomplete tenders, which do not contain all the information called for and the physical sample(s), are liable to be rejected.
- 11.2 The decision of BHEL in respect of evaluation of bids and/or award of contract shall be final.

12.0 CANCEL/SCRAP OF TENDER

- 12.1 BHEL also reserves the right to cancel/ scrap the tender without assigning any reason whatsoever.

13.0 LEGAL DECLARATION

- 13.1 The bidding agencies are required to give a declaration that there is no case with the Police/Court/Regulatory authorities against the proprietor/firm/partner. Also the supplier should not have not been suspended/delisted/blacklisted by any other Govt. Ministry/Department/Public Sector Undertaking/ Autonomous Body/Financial institution/Court. They also need to certify that their Firm /Company or any of the partners are not involved in any scam or disciplinary proceedings settled or pending adjudication. The declarations format is as per Annexure VIII of the tender enquiry.

14.0 CONTRACT TERMINATION

- 14.1 BHEL reserves the right to terminate the contract any time if the execution of work is unsatisfactory or the time schedule is not strictly adhered to.

15.0 AUTHORISED OFFICER

- 15.1 Head of Corporate Communication of BHEL, or any other officer nominated by BHEL, shall be the authorized officer with regard to the Contract. The decision of the authorized officer shall be final and binding on the supplier. The authorized officer shall hold all the meetings at Delhi only.




