SUB: RECEIPT OF EQUIPMENT/ MATERIAL AT SITE, UNLOADING, INSPECTION, VERIFICATION, STORAGE, UP-KEEPING DURING STORAGE, ERECTION, TESTING, COMMISSIONING AND HANDING OVER OF 400 KV SUBSTATION EXTENSION AT BIHARSHARIFF IN BIHAR.

Sealed Tenders (Under two part Bid system) are invited from competent ETC contractors for Receipt of equipment/ material at site, unloading, inspection, verification, storage, up-keeping during storage, erection, testing, commissioning and handing over of 400 kV substation extension at Biharshariff in Bihar. Only those who are technically and financially capable to execute the Job and who fulfil the Pre-Qualifying requirements [PQR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The minimum PQR of contractor for tender submission shall be as under:

- a) Vendors should have a minimum average annual turnover of ₹ 18 lacs for last three financial years (2010-11, 2011-12 & 2012-13) and should submit audited balance sheet and Profit & Loss Account Sheet of these years. In case audited balance sheet is not available due to turnover being less than statutory requirement of audit, bidder should furnish self certified copies of Balance Sheet, Profit & Loss account along with income tax returns of these years.
- b) Vendor should have successfully executed similar job (ref note below) during last seven years ending 28.02.2014. Vendor should produce certification/ proof in support of execution/ executing similar package from user/end user and should be either of the following:
 - i. **Three similar jobs executed costing (except service tax) not less than ₹ 23 lacs each.**

OR
 - ii. **Two similar jobs executed costing (except service tax) not less than ₹ 30 lacs each.**

OR
 - iii. **One similar job executed costing (except service tax) not less than ₹ 47 lacs.**
- c) Vendor should have earned profit in at least one year during last three financial years

NOTE:

1. Similar job shall mean: Bidder should have successfully executed erection, testing and commissioning of 220 kV rating and above substation.
2. In addition to above bidder should have successfully executed ETC works of at least 1 No. 50 MVA or above rating transformer/ 50 MVAR or above rating reactor. This should be completed activity and may be included in above job(s) or separate work of any value.

3. For the similar job the word 'executed' means the bidder should have achieved the criteria specified in the PQR even if the total contract has not been completed or closed. This condition is only for similar work mentioned at Sl. No.1 above.
4. Quotations received from bidders who do not fulfil the PQR are liable to be rejected without any further evaluation and information to bidders.
5. BHEL reserves the right to:
 - (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
 - (b) Postpone the above mentioned date, split and distribute the work among more than one bidder without assigning any reason whatsoever.
 - (c) May ask for further qualification during techno commercial scrutiny of bids received.
6. BHEL shall not be responsible for any delay, loss, damage for bids sent by post.
7. BHEL shall not be liable for any expenses incurred by bidder in preparation of bid irrespective of whether it is accepted or not.
8. Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any bidder found to have engaged in canvassing shall be liable to have his bid rejected summarily.
9. If the bidder deliberately gives any wrong information in his tender to create in circumstances for the acceptance to his bid, BHEL reserves the right to reject such application.
10. Bidder's selection is subject to approval of BHEL's Customer/ Customer's consultant for this work.
