- 3 Items of work other than those mentioned in Bill of Quantities will have to be carried out at the rates to be fixed by this organisation .The same offered percentage will be applicable with reference to CPWD DSR 2012.
- 4 Safety precautions should be taken while doing the work. You will have to follow all safety requirements to carry out the work inside the factory premises.
- 5 **CONTRACT CONDITIONS ON TAXES & DUTIES**

- 8 BHEL will provide water at free of cost by identifying the water source (Open well) within the BHEL premises subject to availability and the contractor has to make their own arrangement for pumping the water from well and using the same after ensuring the suitability for the purpose. In case BHEL is not able to provide water as stated above, the contractor has to make their own arrangement for bringing the required quality of water at their own cost from outside the premises for construction and testing purposes.
- 9 The contractor has to make their own arrangement for the required power supply for the execution of work.
- 10 All materials shall confirm to the latest IS / IRC specifications
