**CIVIL WORK AT HVDC AGRA CONVERTER STATION OF**  
**POWERGRID.**

Expression of interest is invited from competent Civil contractors for Pre-bid tie up for execution and handing over of Civil works of  $\pm 800$  KV, 6000 MW HVDC converter station at Agra in Uttar Pradesh floated by M/s Power Grid vide Tender specification no.C-61901R-S056-8. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying requirements [QR] given under are eligible to submit their Expression of Interest. The minimum QR of contractor for EOI shall be as under:

**A.** Vendors should have a minimum average annual turnover of. **Rs. 40 Crores** for last three financial years ending on 31.03.09 and should submit balance sheet and Profit & Loss Account for last three years ending 31.03.09.

**B.** Vendor should have successfully executed/executing similar job (ref note below) during last seven years ending 31.07.09. Vendor should produce certification/proof in support of execution/executing similar package from user/end user and should be either of the following:

i. **Three similar jobs executed/ executing costing not less than Rs. 50 Crores.**

OR

ii. **Two similar jobs executed /executing costing not less than Rs. 60 Crores**

OR

iii. **One similar job executed / executing work not less than Rs. 100 Crores**

**C.** Vendor should have earned profit in at least one year during last three financial years ending on 31.03.09.

**NOTE:** Similar job shall mean successful executed/executing of civil works of switchyard or substation or power house or industry /infrastructure predominantly concrete work.

**Quotations received from bidders who do not fulfil the QR shall be summarily rejected without any further evaluation and information to bidders.**

**Important Notes**

- 1) BHEL reserves the right to:
  - (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
  - (b) Postpone the dates mentioned in the NIT, split and distribute the work among more than one bidder without assigning any reason whatsoever.
  - (c) May ask for further qualification during techno commercial scrutiny of bids received.
