Sealed Tenders (Under two part Bid system) are invited from competent ETC contractors for execution of subject works and handing over of 400/220 KV switchyard at Ukai in Gujarat. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The minimum QR of contractor for tender submission shall be as under:

- a) Vendors should have a minimum average annual turnover of. **Rs 25 Lacs** and should submit audited balance sheet and Profit & Loss Account for last three years (2005-06, 2006-07 & 2007-08)
- b) Vendor should have successfully executed/executing similar job (**ref note below**) during last seven years ending 31.01.09. Vendor should produce Certification/proof in support of execution/executing similar package from User/end user and should be either of the following:
 - i) **Three similar completed works each costing not less than Rs 30 Lacs.**

OR
 - ii) **Two similar completed works each costing not less than Rs. 35 Lacs.**

OR
 - iii) **One similar completed work each costing not less than Rs 60 Lacs**
- c) Vendor should have earned profit in at least one year during last three financial years (2005-06, 2006-07 & 2007-08)
- d). The contractor should meet the minimum QR for T&P and testing equipments as per Annexure-I.

NOTE:

1. **Similar job shall mean executed/ executing successfully erection, testing and commissioning of complete substation of 220 kV ratings and above.**
