SUB: TENDER FOR EXECUTION AND HANDING OVER OF CIVIL WORKS FOR 400/220 KV SUBSTATION EXTENSION AT BELLARY IN KARNATAKA.

Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and handing over of civil works for 400/220 kV substation extension at Bellary in Karnataka. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying Requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be as under:

- A. Vendors should have a minimum average annual turnover of **Rs.75** lakh for last three financial years ending on 31.03.08. Vendor should submit audited balance sheet and Profit & Loss Account for last three years (2005-06, 2006-07 & 2007-08)
- B. Vendor should have successfully executed/executing similar job (s) (ref note below) during last seven years ending 28.02.09. Vendor should produce Certification/proof in support of execution/executing similar package from User/end user and should be either of the following:
- i. **Three similar jobs executed/ executing costing not less than Rs. 100 lacs.**

OR

 - ii. **Two similar jobs executed /executing costing not less than Rs. 125 lacs.**

OR

 - iii. **One similar job executed / executing work not less than Rs. 195 lacs**
- C. Vendor should have earned profit in at least one year during last three financial years ending on 31.03.08.

NOTE: Similar job shall mean successful executed/executing of civil works of switchyard or substation or power house or industry /infrastructure predominantly concrete work.

Important Notes

- 1) BHEL reserves the right to:
 - (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
 - (b) Postpone the above mentioned date, split and distribute the work among more than one bidder without assigning any reason whatsoever.
 - (c) May ask for further qualification during techno commercial scrutiny of bids received.
- 2) BHEL shall not be responsible for any delay, loss, damage for bids sent by post.
- 3) BHEL shall not be liable for any expenses incurred by bidder in preparation of bid irrespective of whether it is accepted or not.
- 4) Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any bidder found to have engaged in canvassing shall be liable to have his bid rejected summarily.
