Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and handing over of civil works & earthing works for 400 kV switchyard at Srinagar in Uttarakhand. Only those who are technically and financially capable to execute the Job and who fulfil the Qualifying Requirements [QR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The QR of contractor for tender submission shall be as under:

A. Vendors should have a minimum average annual turnover of. **Rs.218 lacs** and should submit audited balance sheet and Profit & Loss Account for last three years (2004-05, 2005-06 & 2006-07 'OR' 2005-06, 2006-07 & 2007-08)

B. Vendor should have successfully executed/executing similar job (**ref note 1 below**) during last seven years ending 31.08.08. Vendor should produce certification/proof in support of execution/executing similar package from user/end user and should be either of the following:

i. Three similar completed/ executing works costing not less than Rs. 291 lacs.

OR

ii. Two similar completed /executing works costing not less than Rs. 363 lacs.

OR

iii. One similar completed/ executing work costing not less than Rs. 581 lacs.

C. Vendor should have earned profit in at least one year during last three financial years (2004-05, 2005-06 & 2006-07 'OR' 2005-06, 2006-07 & 2007-08)

NOTE:

Similar job shall mean successful executed/executing of civil works of switchyard or substation or power house or industry /infrastructure predominantly concrete work.
