<p>Against this enquiry for the subject item/System with detailed scope of supply as per enquiry specifications. BHEL may resort to “REVERSE AUCTION PROCEDURE” i.e., ON LINE BIDDING (THROUGH A SERVICE PROVIDER). The philosophy followed for Reverse Auction shall be English Reverse (No ties)</p>	
1	<p>For the proposed reverse auction , technically and commercially acceptable bidders only shall be eligible to participate.</p>
2	<p>Those bidders who have given their acceptance for Reverse Auction (quoted against this tender enquiry) will have to necessarily submit “online sealed bid” in the Reverse Auction. Non-submission of “online sealed bid” by the bidder for any of the eligible items for which techno-commercially qualified, will be considered as tempering of the tender process and will invite action by BHEL as per extant guidelines in vogue.</p>
3	<p>BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of on line bidding on internet</p>
4	<p>In case of reverse auction, BHEL will inform the bidders , the details of Service Provider to enable them to contact &amp; get trained.</p>
5	<p>Business rules like event date, time ,bid decrement, extension etc., also will be communicated through service provider for compliance.</p>
6	<p>Bidders have to fax the compliance form in the prescribed format before start of Reverse Auction. Without this, the bidder will not be eligible to participate in the event.</p>
7	<p>In line with the NIT terms, BHEL will provide the calculation sheet (e.g EXCEL Sheet) which will help to arrive at “Total Cost to BHEL” like Packing and Forwarding charges, Taxes and Duties, Freight Charges, Insurance, Service tax for Services and loading factors (for Non-compliance to BHEL standard Commercial terms and conditions) for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.</p>
8	<p>Reverse Auction will be conducted on scheduled Date and Time.</p>
9	<p>At the end of Reverse Auction event, the lowest bidder value will be known on auction portal.</p>
10	<p>The lowest bidder has to fax/e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required in the prescribed format as proved on case-to-case basis to Service Provider within two working days of Auction without fail.</p>
11	<p>In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the price bids and price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL’s standard practice.</p>
12	<p>Bidders shall be required to read the “Terms and Conditions” section of the auctions site of Service Provider, using the Login IDs and passwords given to them by the service provider before reverse auction event. Bidders should acquaint themselves of the “Business Rules of Reverse Auction”, which will be communicated before the Reverse Auction.</p>
