02. Based on the above, the price schedule has been modified and enclosed herewith as rev-1. The earlier price schedule stands cancelled and replaced by Price schedule, REV-1.
03. The clause no.54.2 of Volume-ID and clause no. 5.0 of Preamble to price bid (tonnage variation) stands revised as under :

For Gr.VII (Final Painting) : 100% payment shall be made on supply & application of final painting.

However, it may be noted that items/components on which final painting has been applied shall be measured & considered for payment purpose. Identification of such components shall be as per direction of BHEL Engineer.

For Gr. IX (UNLOADING OF BOILER DRUM) : 100% payment shall be made on unloading of the boiler drum at the designated place.

For Gr.X (PROVIDING PG TEST ASSISTANCE): 100% payment shall be released on completion of the PG test.

The clause no. 53.3.4.10. is modified and replaced as under :

53.3.4.10	The 5% of contract value, retained from each RA bill, will be released on completion of guarantee period. However, this 5% payment can be released against submission of performance bank guarantee valid for the guarantee period as stated above in prescribed pro-forma subject to liquidation of all pending points/punch points, reconciliation of issued materials, completion of contractual obligation and contract closing in all respect. The submission of bank guarantee towards performance guarantee is separate and the bank guarantee towards security deposit cannot be utilized for this purpose. The security deposit will be refunded as per GCC.
