Sub: -Conversion of "CRGO OFFCUT SCRAP TO FINISHED DRY TYPE & SMALL TRANSFORMERS LAMINATION".

**(1) Annexure 'B' - page 5 Clause 1 b)-**

**Existing Clause :**

“Sorting, shearing and punching of CRGO offcut to convert it into laminations for DTT and small transformer as per Core sheet drawings.”

**Revised Clause:**

“Sorting, shearing & punching of CRGO offcut to convert it into laminations of DTT & small transformer as per core sheet drawing. BHEL shall ensure that enough offcuts are available for conversion. In case there is shortage of offcuts BHEL shall provide ex- rolls / fresh rolls so that conversion does not stop.”

**(2) Annexure 'B' - page 5 Clause 1 h)-**

**Existing Clause:**

“All the machines, material, electricity, compressed air, consumables, and tools available with BHEL shall be provided by BHEL free of cost.”

**Revised Clause:**

“All the machines, material, electricity, compressed air, consumables tools available with BHEL shall be provided by BHEL free of cost. The machines shall be maintained by BHEL free of cost. However contractor may bring their machines& tools at their own cost and risk. BHEL shall provide space and power free of cost. Erection and maintenance of machines brought by contractor shall be done by contractor at their risk and cost.
