Techno-commercial bid and Price bid should not be put together in a single cover in open condition. Only the cover consisting of Techno-Commercial Bid will be opened on the due date in the presence of those vendors or their Authorised representatives who wish to be present. The due date may be altered in case of insufficient response or urgency or other reasons deemed as valid. Refloating may also be resorted to with or without opening the received responses. The tenders meeting our Techno-Commercial requirements will be considered for Price Bid opening at a later date for which eligible vendors will be intimated in due course.

Following Terms & conditions should be clearly mentioned in your offer

1. Prices to be Quoted on **F.O.R. BHEL EPD Stores**, along with applicable Taxes and Duties.
2. Service Tax, if any, to be mentioned with applicable rate.
3. Packing & Forwarding charges, if any
4. Freight & Insurance charges, if any
5. Lead time required for supply : **with in 2 Weeks** and Erection & commissioning in **one week**.
6. **Payment:** 80% shall be made within in 30 days time from the date of receipt of material, 20% on completion of E&C .
7. Erection / Installation & Commissioning charges, if any, to be quoted separately
8. Warranty: 12 Months from the date of E&C or 18 Months from the date of supply, whichever is earlier.
9. LD Clause: :0.5% per week up to a maximum of 10% of the undelivered value of the order for delayed period.
10. Risk Purchase Clause is applicable as per BHEL Norms. Failing to accept this clause may result in rejection of offer.
11. VALIDITY: Offer should be kept valid for 60 days

NOTE: If there are more than one item specified in the enquiry, L-1 will be decided based on overall landed cost to BHEL.

LOADING FACTOR:

If the offer is not in line with the terms & conditions specified by BHEL, the following loading criteria `will be adopted for evaluation.

A) Payment terms: For any deviation to the payment term offered w.r.t NIT, the loading shall be referenced with prime lending rate of SBI + 2% for the period of relaxation sought.

B) Transportation charge:

as per BHEL Rate contract prevailing on the date of opening of tender

C) Transit Insurance:

as per BHEL Rate prevailing on the date of opening of tender

D) Liquidated damages:

loading on LD clause shall be to the extent to which it is not agreed.

E) For delay in delivery period wrt tender schedule:
