PRE QUALIFICATION

The following conditions have to be satisfied by the tenderer, with documentary proof to be enclosed with tender bid. **In case the agency fails to enclose the following documentary proof with tender the tender will be liable for rejection.**

I.

Particulars of experience for the works executed of similar nature (Completion certificates to be enclosed). Shall have experience of execution of above works as per the pre-qualification criteria in technical bid. **Similar works:** As mentioned in the respective works of technical bids.

1. (a) **ESI code .**

(b) **P. F. Code No.**
- 2 Labour licence (Central / State Government) before commencement of work.
- 3 **PAN No.** (in case not available, proof of having applied with acknowledgement from concern authorities)
- 4 **APGST** (in case not available, proof of having applied with acknowledgement from concern authorities) (**It is required to furnish VAT registration certificate issued by Commissioner, Commercial taxes, AP Govt, in respect of all works costing more than Rs. 5.00 lakhs each).**
- 5 . **Service Tax registration no:** in case not available, proof of having applied with acknowledgement from concern authorities before commencement of work.
6. Period of completion shall be as mentioned in NIT.
7. Penalty: 0.50 % of the gross value of work will be levied for every weeks delay by the agency subject to a maximum of 10 % value of the work.
