- 5 . **Service Tax registration no:** in case not available, proof of having applied with acknowledgement from concern authorities Before commencement of work.
6. Period of completion shall be as mentioned in NIT.
7. Penalty: 0.50 % of the gross value of work will be levied for every weeks delay by the agency subject to a maximum of 10 % value of the work.
