PRE QUALIFICATION

Particulars of experience for the works executed of similar nature (Completion certificates to be enclosed). Shall have experience of execution of above works as per the pre-qualification criteria in technical bid. **Similar works:** As mentioned in the respective works of technical bids.

1. (a) **ESI code (The agency has to attach the proof if not available agency should give undertaking that they will obtain before awardal of work in case they become L1).**

(b) **P. F. Code No.**

2 Labour licence (Central / State Government) before commencement of work.

3 **PAN No.** (in case not available, proof of having applied with acknowledgement from concern authorities)

4 **APGST** (in case not available, proof of having applied with acknowledgement from concern authorities) **(It is required to furnish VAT registration certificate issued by Commissioner, Commercial taxes, AP Govt, in respect of all works costing more than Rs. 5.00 lakhs each).**

5 . **Service Tax registration no:** In case not available, proof of having applied with acknowledgement from concern authorities Before commencement of work.

6. Period of completion shall be as mentioned in NIT.

7. Penalty: 0.50 % of the gross value of work will be levied for every weeks delay by the agency subject to a maximum of 10 % value of the work.
