I. ELIGIBILITY CRITERIA

1. The Bidder should have valid Service Tax registration number and PAN Card. Documentary proofs / Xerox copies are to be enclosed.
2. The agency could be a Proprietorship/ Registered Firm / Private or Public Company registered under company's Act and a well-established reputed organization in this line of service / business - documentary proof / Xerox copy to be enclosed.
3. The Contractor should have horticulture experience in the industry/ institution for a period of minimum three years over the last ten years. The list of clients, present and past, should be enclosed and contract completion / performance certificate from past client(s) has to be furnished as documentary evidence.
4. Only those bidders, who are meeting all the above qualifying criteria, will be considered for further evaluation and others will be summarily rejected.
5. The eligibility Criteria details as per **Annexure - X** to be filled & submitted with supporting documents for BHEL reference and verification.

II. SCOPE OF CONTRACT:

1. **Earthwork excavation:**

Scope of work: Earthwork excavation in ordinary soil to a depth of 60 cm including removal and stacking of serviceable materials and then disposing of by spreading and neatly leveling with in a lead of 50 m and making up the trenched area to proper levels by filling with earth mixed with sludge or manure before and after flooding trench with water (excluding cost of earth, sludge and manure). All as per the instruction of Engineer incharge.

2. **Digging holes in ordinary soil:**

Scope of work: Digging holes in ordinary soil and refilling the same with the excavated earth mixed with manure or sludge in the ratio of 2:1 by volume (2 parts of stacked volume of earth after reduction by 20% : 1 part of stacked volume of manure after reduction by 8%) flooding with water, dressing including removal of rubbish and surplus earth, if any with all leads and lifts (cost of manure, sludge or extra good earth if needed to be paid separately) Holes 60cm dia and 60cm deep. All as per the instruction of Engineer incharge.

3. **Uprooting rank vegetation and weeds:**

Scope of work: Uprooting rank vegetation and weeds by digging the area to a depth of 60 cm removing all weeds and other growth with roots by forking repeatedly, breaking clods, rough dressing, flooding with water, uprooting fresh growths after 10 to 15 days and then fine dressing for planting new grass, including disposal of all rubbish with all leads and lifts. All as per the instruction of Engineer incharge.

4. **Supply and Stacking at site - River sand:**

Scope of work: Supply and stacking at site (at BHEL/PPPU factory) – River sand (No voids) as per the instruction of Engineer incharge. Rate includes loading, transportation & unloading charges.

5. Supply and Stacking at site - Red Earth:

Scope of work: Supply and stacking at site (at BHEL/PPPU factory) – Red Earth (No voids) as per the instructions of Engineer incharge. Rate includes loading, transportation & unloading charges.

6. Supply and Stacking at site – Earth:

Scope of work: Supply and stacking at site (at BHEL/PPPU factory) – Earth (will be reduced by 20% for voids) as per the instructions of Engineer incharge. Rate includes loading, transportation & unloading charges.

7. Supply and Stacking at site – Manure:

Scope of work: Supply and stacking at site (at BHEL/PPPU factory) – Cattle Manure (will be reduced by 8% for voids) as per the instructions of Engineer incharge. Rate includes loading, transportation & unloading charges.

8. Conveyance of Earth:

Scope of Work: Conveyance of earth in and around the factory within a radius of 2 kms using contractors own lorry including loading, leading, conveying as per the instructions of Engineer in charge. The rate shall be inclusive of all labour, tools, equipments, fuel & hire charges for lorry.

9. Filling mixture of earth and sludge:

Scope of work: Filling mixture of earth & sludge or manure in the desired proportion in pits, flooding with water and leveling as per the instruction of Engineer incharge (cost of supplying earth and sludge or manure and mixing excluded)

10. Spreading of sludge:

Scope of work: Spreading of sludge, dump manure or good earth in required thickness (for Lawn) as per the instruction of Engineer incharge. The rate shall be inclusive of all labour, tools & equipments. (cost of earth, sludge or manure, mixing and filling excluded)

11. Grassing with "Doobs" grass:

Scope of work: Grassing with "Doobs" grass including watering and maintenance of the lawn for 30 days or more till the grass forms a thick lawn free from weeds and fit for mowing including supplying good earth if needed as per the instruction of Engineer incharge (the cost of good earth excluded)

12. Hiring of earth moving machineries (JCB):

Scope of work: Hire charges for engaging earth moving machineries (JCB). Rate includes hire, fuel, operation charges, to and fro charges for machinery, all labour (minimum one operator and one helper) and all other incidentals etc., complete.(A day means 8 hours of working)

13. Planting of Tree saplings/plants:

Scope of work: Conveying tree saplings / plants from stack within the factory premises and planting the same in the pits excavated, initial watering, forming bed etc., all as per instruction of Engineer in charge. Cost of Tree saplings/ plants to be paid separately. Rate includes conveyance of plants, loading, unloading, lifting planting initial watering etc.

14. Maintaining the shrubs plants:

Scope of work: Maintaining the shrub plants available at various locations which covers watering once in two days, weeding, mulching the top soil to a depth of 15 cm once in three months, making basin to proper size, manuring, cutting the area etc., complete. Replanting is also to be done whenever necessary. All as per instructions of engineer in charge. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc.

15. Maintaining the hedges:

Scope of work: Maintaining the hedges (up to a height of 1.50 m) available at various locations in BHEL. Maintenance covers watering once in two days, weeding, mulching the top soil to a depth of 15 cm once in three months, making basin along the hedges, manuring and cutting, pruning, trimming the hedges once in a month, cleaning the areas, disposing off all wastes, cut branches, leaves etc. in the nearby areas within a lead of 100 metre etc. complete. Replanting is also to be done as and when necessary. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc. complete. All as per instructions of Engineer-in-charge. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc. complete. Rate is maintaining one metre per month.

16. Maintaining and safeguarding the lawns:

Scope of work: Maintaining and safeguarding the lawns including flower beds available at various locations in BHEL. Maintenance covers watering once in two days, periodical weeding, mowing, scraping, raking, replacing flower beds, mulching the top soil and forming basins etc. all once in 45 days, manuring, cleaning the areas, disposing off all wastes, dried leaves etc. in the nearby areas within a lead of 100 metre etc. complete. Re-lawn is also to be done as and when necessary. All as per instructions of Engineer-in-charge. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc. complete. Rate is for maintaining one sqm per month.

17. Maintenance and protection of trees:

Scope of work: Maintenance and protection of avenue tree plants available at various locations in BHEL. Maintenance covers watering once in two days, protecting the plants from cattle menace and theft by providing thorny fencing, periodical weeding, maintaining the area free from other vegetation growth, mulching the top soil and forming basin, manuring, cleaning the area etc. complete. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc. complete. All as per instructions of Engineer-in-charge. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc. complete. Rate is for maintaining one tree per month.

18. Maintaining the potted plants:

Scope of work: Maintaining the potted plants available at site and other locations by watering once in two days, mulching and weeding the soil once in a fortnight, application of manure/fertilizer/pesticides as and when required (normally three times in an year) pruning and shaping as and when required, repotting the plant once in a year, replacement of broken pots (pots will be supplied by BHEL), propagation of different species of plants as directed etc. complete. Rate includes all labour, tools, hose pipes, water carts, all incidentals etc. complete. All as per instructions of Engineer-in-charge. Rate includes cost of fertilizers and pesticides. Rate is for maintaining one potted plant per month.

19. Supply of tree saplings:

Scope of work: Supply of tree saplings around 5feet in height for planting at site. Rate includes cost of tree saplings, loading, transportation from nursery to PPPU/BHEL, unloading and stacking. All as per the instructions of engineer incharge.

20. Supply of shrubs/ hedge plants:

Scope of work: Supply of shrubs/ hedge plants for planting at site. Rate includes cost of shrubs/hedge plants, loading, transportation from Nursery to PPPU/BHEL, unloading and stacking. All as per the instructions of engineer incharge.

21. Ploughing the existing ground:

Scope of work: Ploughing the existing ground to a depth of 15 cm to 25 cm manually or mechanically as per the instructions of Engineer incharge.

22. Labour charges for mixing:

Scope of work: Labour charges for mixing the earth, red earth, sand, manure, coconut waste etc. thoroughly to the required proportion and carrying the same and filling it in the excavated pits/ areas at various locations with all leads and lifts. Rate excludes cost of materials and filling.

III. WORK SPECIFIC TERMS & CONDITIONS:

1. The Scope of works includes formation of Lawns & development of garden and maintenance inside Power Plant Piping Unit (PPPU), BHEL, Thirumayam.
2. Time is the essence of the contract. The contractor should make all efforts to complete the work in time i.e. within completion period of 12 months.
3. The tenderers are advised to visit the BHEL/PPPU, Thirumayam and get themselves acquainted with the site conditions before submitting the bids.
4. Contract Value is only approximate and liable for variation without entitling the tenderer to any compensation, till the total value of contract vary by more than 20% (Twenty percentages).
5. The item rate offered is for finished item of works and shall provide for the complete cost towards fuel, tools, tackles, plant & machinery, temporary works, labour, materials, levies, taxes, transport, lay-out, repairs, rectifications, maintenance till handing over, supervision, labour colonies, establishment, services, roads, revenue expenses, overheads, profits & all other incidentals etc., complete. However if the service tax is applicable for this contract work and free issue materials, the same will be reimbursed on production of valid document proof for having paid service tax by the contractor.
6. Some changes are likely in the quantities furnished as well as in the layout, design and specifications of the work. The rates quoted shall be deemed to be inclusive of all such contingencies.
7. Usually, working hours are limited to day time only. In emergency cases to carryout works during nights, it may be done so with the specific prior permission of BHEL. In such case, it is to be carried out in the presence of BHEL officials or their authorized persons.

8. The work shall be carried out as per Civil Engineering Department Work & Safety procedure, and as per the instructions of Engineer-in-charge. The brief description of items of work is given in the bill of quantities provided in the Price Bid. Tenderer has to quote rates both in figures and in words for all the items given in the Bill of Quantities provided in the Price Bid.
9. For any item of work not covered in Scope of work/Price Bid, the rate will be arrived at based on the conditions given in BHEL General Conditions of Contract in force.
10. The contractor should bring the earth moving machineries like Poclain, JCB etc., as and when required for the work without any delay. Also required tools & Plants / equipment shall be made available always at site for the works.
11. The contractor has to arrange sufficient number of Lorries to collect & transport the surplus earth, construction debris generated, etc. at site. Otherwise BHEL would clear the debris at the contractor's risk and cost.
12. The contractor has to execute any item of work irrespective of the quantity available in the tender without any reservation till the contract value does not vary more than 20%.
13. Statement of completed works with detailed measurements along with material reconciliation statements shall be submitted by the contractor in the first week of succeeding month for processing bill.
14. The decision of Engineer-in-charge shall be final and binding on the contractor regarding clarification of items in this tender schedule.
15. The contractor shall follow norms of BHEL security system for movement of men & materials within the complex.
16. Separate non-technical persons should be engaged for arranging daily gate passes for labours and vehicles entry in all the gates of Factory Complex.
17. Contractor's materials and tools & plants shall have to be brought inside factory with proper invoice / voucher and make necessary entry in the security gate. They should maintain proper record for tools and plants, materials, etc., brought inside the factory complex.
18. The contractor should extend full co-operation to the other contractors who may be doing other works in the same areas to enable them to execute their portions of work without any delay or difficulty.
19. Water and electricity will be provided at one point by BHEL free of cost.
20. Tenderers are requested to furnish the duly filled in E format attached as separate sheet along with a original cancelled cheque leaf to accept Electronic fund transfer / R T G S transfer for any payment from BHEL, Thirumayam.
21. No advance / mobilization advance will be given.

22. Normally work will be carried out on all days except Sundays & public holidays. However in case of urgency, the contractor has to work on Sundays also.
23. Tools, accessories, pumps, vehicles and water carts shall be arranged and maintained by the contractor at his own cost for this work.
24. Minimum of 6 persons and one supervisor should be engaged every day for maintenance activity for the activities (Serial No. 14, 15, 16, 17 & 18 covered under Scope of Work above). For all other activities the contractor has to deploy extra manpower. However, more number of labours should be deployed when required by BHEL in case of urgent work to the entire satisfaction of BHEL.
25. The Contractor's personnel should wear uniform inside BHEL complex.
26. The entire horticulture work to be carried out inside BHEL/PPPU factory, Thirumayam.

IV. COMMERCIAL TERMS & CONDITIONS:

01. RATE:

- (a) **The rates quoted should be valid for 90 days initially from the date of opening of the price bid.** The rates of successful bidder should be valid for one year from the date of commencement of the contract.
- (b) The rates quoted should be exclusive of service tax and inclusive of any other taxes & duties levied or to be levied both by Central and State Government Authorities. Such levies should be borne by the Contractor.
- (c) All entries in the tender documents should be in one ink. Erasures and overwriting are not permitted. All cancellations and insertions should be duly attested by the Bidders concerned.
- (d) Rates should be quoted as per the Work / Rate schedule. Rates quoted in any other form will not be accepted and will be rejected.
- (e) Unit rates should be quoted in figures as well as in words for all the items shown in the attached schedule. Wherever there is a difference in the two, **the rates in words will be taken as final.**
- (f) Service Tax Payment will be reimbursed as per statutory provisions, subject to production of proof of payment / remittances.
- (g) Contractor has to ensure that all statutory payment as per Minimum Wages Act / Payment of Wages Act etc. and BHEL additional monthly payment (as indicated in Welfare Conditions) to be taken care of while quoting. No claim in respect of payment to workmen will be entertained at a later stage. It will be responsibility of contractor to comply with statutory payments to workmen in this regard.

02. PAYMENT TERMS:

- (a) Statement of completed works with detailed measurements along with material reconciliation statements shall be submitted by the contractor in the first week of succeeding month for processing bill along with supporting documents (measurement book).
- (b) The consolidated statements and Bills shall be prepared by the Contractor during the first week of succeeding month and submitted after due certification by the Civil Section / Executive. The payment will be made through RTGS / EFT to the contractor immediately after the receipt of the error free bill.

03. PENAL CLAUSE:

Non-Compliance of tender clause will attract penal charges and the penal charges for the important parameters (non-compliance activities) will be intimated at the time of award of contract.

04. CONTRACT PERIOD

- (a) The contract execution period will be for a period of one year from the date of Ordering.
- (b) If required, BHEL reserves the right to extend this subject contract for a further period under same terms and conditions subject to mutual acceptance of both parties.
- (c) The contract may be terminated by BHEL due to violations or non-performance of the Contract conditions by giving one month's notice. In the event of contractor requiring termination, he has to provide 4 months' notice to BHEL.

05. SECURITY DEPOSIT:

- (a) Security Deposit should be paid by the contractor. Security Deposit shall be collected from the successful Bidder as shown below:

Contract Value Up to Rs.10 Lakhs	: 10%
Above Rs.10 Lakhs up to Rs.50 Lakhs	: 1 Lakh + 7.5% of the amount exceeding Rs.10 Lakhs
Above Rs.50 Lakhs	: 4 Lakhs + 5% of the amount exceeding Rs.50 Lakhs

The Contractor should remit the Security Deposit before start of the work. The EMD amount shall be converted as security deposit and the balance amount shall be remitted.. No interest will be paid to the Contractor for the amount deposited during the period of agreement.

Failure to pay the security deposit shall be treated as failure to discharge the duties under the contract and shall result in cancellation of the contract and the Bidder shall be liable to compensate BHEL for any losses incurred by BHEL. EMD in such cases shall be forfeited.

The security deposit shall be refunded within a reasonable time after the date of successful completion of the contract i.e. the Contractor carrying out all obligations / operations as required under the contract agreement.

VI. GENERAL TERMS & CONDITIONS:

- (d) "The **Officer-In charge**" means, the Officer deputed by the, Dy. General Manager/Administration to supervise the work or part of the work.
- (e) "**Approved**" and "**Directed**" means, the approval or direction of Dy. General Manager/Administration, or person deputed by him for the particular purposes.

05. REGISTERS & RECORDS:- The Contractor shall maintain all registers and records in the proper manner and as required by the regulations of the various authorities concerned and indemnify the Employer from the consequences due to any inaccurate or faulty documentation on the part of the Contractor.

27. REMOTE TRANSACTIONS:- The Contractor shall agree to and comply with all such terms and conditions as BHEL may prescribe from time to time and shall confirm that all transactions effected by or through facilities for conducting remote transactions including the Internet, World Wide Web, electronic data interchange, call centers, tele-service operations (whether voice, video, data or combination thereof) or by means of electronic, computer, automated machines network or through other means of telecommunication established by BHEL shall constitute legally binding and valid transactions when done.

28. CHANGE IN CONSTITUTION OF FIRM: - Changes in constitution of firm whenever it is made after submission of application or during currency of the contract, the existing firm has to duly inform the proposed changes to contracting department of BHEL at the appropriate time before the changes in the constitution are made. In case the absence of any such information BHEL is not responsible for the consequences arising out of the absence or suppression of information and the issue / dispute arising out of these changes and the firm is responsible for settling the issue or dispute among themselves (Partners etc.) or with the bankers or with any third party. Under the above circumstances when dispute arises and the firm does not inform the change in the constitution of the firm BHEL reserves its rights for suspending or terminating the contract.
