### **DETAIL OF WORK**

#### **1.0 SCOPE OF WORK**

The work comprises of routine checking, Preventive, Breakdown maintenance and general upkeep of all:

- (a) EOT CRANES:**  
This includes all Electric overhead cranes varying from 5 to 125 Ton Capacity of all makes including D.S Lead, main switches etc.(Qty-51 nos, detail as per Annexure-B, Page 5-8).
- (b) SEMI GANTRY CRANES:**  
This includes all Semi gantry cranes varying from 2 to 3 Ton Capacity of all makes including D.S Lead, main switches etc.(Qty-6 nos, detail as per Annexure-B, Page 5-8)
- (c) JIB CRANES:**  
This includes all Jib cranes equipped with hoist of Techno Commercial, Tak, Reva Ltd. etc. varying from 1 to 2 Ton Capacity (Qty-18 nos. detail as per Annexure-B, Page 5-8).
- (d) HOT CRANES:**  
This includes all Hand operated overhead cranes varying from 2 to 10 Ton Capacity of all makes (Qty-04 nos, detail as per Annexure-B, Page 5-8).
- (e) GOLIATH CRANE**  
This includes 01 NO Cranex make 25 ton capacity Goliath crane (detail as per Annexure-B, Page 5-8).
  - Any additional crane if it is added will be covered automatically under the preview of this contract.

#### **2.0 PREVENTIVE MAINTENANCE**

- Preventive maintenance work of cranes shall be done once a year for each crane and shall be confirmed as per our checklist along with Cleaning and alignment of D.S. Lead of cranes and semi gantry cranes.
- Preventive maintenance schedule shall be prepared and shall be completed in time.
- Contractor shall arrange to take up the preventive maintenance of crane on Sunday and Holidays, only after ensuring the release from the area maintenance in charge. The crane may also be taken for preventive maintenance in weekdays with prior approval of maintenance/production. For working on Sunday and Holiday prior approval of maintenance in charge and CISF, BHEL, Jhansi is necessary.
- Monthly Preventive maintenance report shall be prepared and sent to Sr. Manager (WE&S) after counter signed by Crane Maintenance in charge along with all check lists.

#### **3.0 BREAKDOWN MAINTENANCE**

- Breakdown shall be reported on Breakdown report form by the production/user directly.
- After endorsing the date & time of receipt, breakdown shall be attended.
- Immediately after attending of breakdown, supervisor shall report back to production for their endorsement. Supervisor shall also inform the area maintenance in charge of respective area regarding handing over of the crane to production / user.

- A daily breakdown report and report of major work done shall be prepared and submitted to Sr.Manager (WE&S) along with all attended breakdown reports, after its endorsement from in charge crane maintenance.

**4.0 SCOPE OF CONTRACT WORK FACILITY**

- 4.1 Contractor shall arrange his own tools and tackles for removal, dismantling, assembling and re-installation of hoist, motor, gear boxes etc. however all the spares including consumable like gear oil, grease, cotton waste, Electrical items, gas cutting, welding and machining facilities, repair and rewinding of motors, coils etc. shall be provided by BHEL, Jhansi free of cost at ground level but vigilant for arrangement of genuine spares substitution by better parts/methods are to be adopted voluntarily by the contractor to minimize the breakdown time.
- 4.2 To carry out the above mentioned work during total contract period the contractor will deploy adequate numbers of workers with a adequate knowledge and experience with an approval of section / maintenance in charge. Work shall be done in First and Second shifts. However during production peak period, work in third shift may also be done in some areas as instructed by the in charge crane maintenance.
- 4.3 A responsible and competent supervisor shall be posted to co-ordinate and supervise only to the work of preventive and breakdown maintenance of cranes in factory in all three shifts.
- 4.4 The contractor has to provide sufficient staff of experienced electricians, fitters and to help them proper helpers minimum up to twelve nos. per day.
- 4.5 Contractor shall maintain all records like work requisitions form, spare list, and all other records pertaining to his work.

**5.0 URGENT WORK**

- 5.1 The contractor shall have to comply with the priorities fixed by the crane maintenance in charge or for taking urgent repair work.

**6.0 PENALTY CLAUSE**

- 6.1 All breakdowns are to be attended on the same day of reporting. In any case it should be within 24 hrs. of reporting time.
- 6.2 Breakdown pending for want of spares/burnt motor replacement will be attended within 24 hrs.after getting the replacement.
- 6.3 A penalty of Rs. 250/- per day per crane shall be charged maximum to Rs. 5000/- per month.
- 6.4 If for any valid reason it is not done within the stipulated period written information should be submitted to the In charge Crane Maintenance for due consideration.

**7.0 CANCELLATION OF CONTRACT IN FULL OR PART**

Contract shall be cancelled in full or part if the contractor:

- (a) At any time makes defaults in proceeding with the work with due negligence and continuous to do so after a notice in writing or 7 days from the AGM (WE&S), BHEL, Jhansi
- (b) Commits defaults in complying with any if the terms and conditions of the contract.

**8.0 PERIOD OF CONTRACT**

8.1 The period of contract will be for Twelve months from the date of award the work order.

**9.0 GENERAL TERMS & CONDITIONS**

- 9.1 The contract shall include complete repair of Mechanical, Electrical, Electronic, Hydraulic, Structural, Pneumatic, Radio remote etc. incorporated in the cranes.
- 9.2 Contract shall keep all staff orderly in proper uniform and arrange to provide them the work of repair/ manufacture of spares in their idle times.
- 9.3 No foreign/used/unused/scrapped/broken parts shall be left on the crane gantry/bridge to avoid falling of the same and causing accidents.
- 9.4 All used/worn-out/scrapped/replaced spares/parts shall remain the property of BHEL, Jhansi. These items shall be return to WE&S store.
- 9.5 BHEL, Jhansi shall not be liable for any compensation what so ever in the event of accident/injury to the persons employed by the contractor, however, First Aid facility shall be rendered free of cost.
- 9.6 Utmost care should be taken by the contractor to repair the crane in proper way & with Quality workman ship so as to satisfy the safety requirements as per Factory Act, 1948 Section 19 & U.P. Factories Rules 1950 Rule 55-A & subsequent amendments enforced from time to time.
- 9.7 As our company being accorded with ISO 9001, ISO 14001 and OHSAS 18001, contractor are required to carry out work confirming to our quality standards along with necessary documentation/paper work.
- 9.8 In the event of requirement of material/ spares etc. contractor will approach maintenance in charge along with required paper work, who will authorize/counter sign the same for withdrawal. Contractor will make own arrangement to collect the material/spares from its initial point of supply of store.

  - (iv) No dues certificate from contractor regarding Service Tax payment & any other dues liable to remitted by contractor under Financial Laws to Finance department.
  - (v) In case of non-satisfactory performance of the contract, BHEL shall have a right of forfeiting the security deposit. In case of any dispute decision of concerned Head of the Department will be final.

**13. Risk & Cost:**

If the Contractor fails to perform/execute the work within time or fail to perform as per the specification prescribed in tender or acted in violation to prescribed terms and conditions, BHEL-Jhansi shall be entitled to terminate the Contract and take recourse to alternate source to get the work done at the risk and cost of the Contractor. Any matter of dispute arising out of or in connection with this contract shall be under Jurisdiction of Jhansi Court only.

**19. Arbitration:-**

All disputes arising in connection with the contract shall be settled by mutual consultation. If no agreement is reached the dispute shall be settled in accordance with Arbitration and conciliation Act, 1996 and the rules made there under. The dispute shall be referred for arbitration to any arbitrator to be appointed by the Head of the unit (BHEL Jhansi).

The award of the arbitrator shall be final and binding on both the parties. The venue of the Arbitration shall be at Jhansi in India. The Award to be given by the Arbitration shall be a speaking award. All questions, disputes, differences arising under, out of or in connection with this contract shall be to the exclusive jurisdiction of Jhansi court.
