**SUB: EXECUTION AND HANDING OVER OF GROUND IMPROVEMENT WORK BY COMPACTION
STONE COLUMN OF 220 KV SWITCHYARD AT BARAUNI IN BIHAR**

Sealed Tenders (Under two part bid system) are invited from competent civil contractors for execution and handing over of ground improvement work by compaction stone column of 220 kV switchyard at Barauni in Bihar. Only those who are technically and financially capable to execute the Job and who fulfil the Pre-Qualifying Requirements [PQR] given under are eligible to quote against the above NIT. Tenderers should submit their offer in a sealed envelope as per the procedure specified in tender documents. The PQR of contractor for tender submission shall be as under:

- A. Vendors should have a minimum average annual turnover of. **Rs. 85 lacs** and should submit audited balance sheet and Profit & Loss Account for last three years (2009-10, 2010-11 & 2011-2012)
- B. Vendor should have successfully executed similar job (**ref note 1 to 4 below**) during last seven years ending 30.04.13. Vendor should produce certification/proof in support of execution of similar package from user/end user and should be either of the following:
- i. **Three similar jobs executed costing not less than Rs. 115 lacs each.**
 - OR
 - ii. **Two similar jobs executed costing not less than Rs. 145 lacs each.**
 - OR
 - iii. **One similar job executed costing not less than Rs. 235 lacs**
- C. Vendor should have earned profit in at least one year during last three financial years (2009-10, 2010-11& 2011-12)

NOTE:

1. **Similar job shall mean: Bidder should have successfully executed civil works of switchyard or substation or power house or industry /infrastructure including foundation work, building works etc.**
2. **The bidder must have experience of execution of piling work (Driven/ Bore cast in situ pile) and must be in a position to organize 3 rigs for parallel operation.**
3. **In case experience sought at point no. 2 is not included in the work order/certificate submitted by the bidder under point no 1 above to fulfil the financial criteria mentioned at B it shall be mandatory for the bidder to submit additional qualifying work to meet the requirement at point no. 2 above.**
4. **The word 'executed' means the bidder should have achieved the criteria specified in the PQR even if the total contract has not been completed or closed.**
5. **Bidder should provide under taking towards ownerships of 3 mechanical/ hydraulic rigs or should have a tie-up with agency(s) in the form of contract agreement/ collaboration agreement for deployment of the same immediately on award of work and should submit the agreement with their technical offer.**

Important Notes

- 1) BHEL reserves the right to:
 - (a) Accept or reject any bid received at its discretion without assigning any reasons whatsoever.
 - (b) Postpone the above mentioned date, split and distribute the work among more than one bidder without assigning any reason whatsoever.
 - (c) May ask for further qualification during techno commercial scrutiny of bids received.
- 2) BHEL shall not be responsible for any delay, loss, damage for bids sent by post.
- 3) BHEL shall not be liable for any expenses incurred by bidder in preparation of bid irrespective of whether it is accepted or not.
- 4) Quotations received from bidders who do not fulfil the PQR shall be summarily rejected without any further evaluation and information to bidders.
- 5) Canvassing i.e. soliciting favour, seeking advantage etc. in any form is strictly prohibited and any bidder found to have engaged in canvassing shall be liable to have his bid rejected summarily.
- 6) If the bidder deliberately gives any wrong information in his tender to create in circumstances for the acceptance to his bid, BHEL reserves the right to reject such application.
- 7) Bidder's selection is subject to approval of BHEL's customer/ customer's consultants for this work.
